Sir

In producing here with the accused person namely Arjun Mahato (55/M) S/O Late Laxmi Mahato of NewGanganagar near Noni Babu road, ward No.05, PS- Siliguri, Dist- Darjeeling along with seized 21 (twenty one) bottles of Himalaya Gold 60 up Country spirit containing 600 ML in each bottle mentioning M.R.P of Rs- 100/-in each bottle i.e. total amount of Rs- 2100/-(Rs/- two thousand One hundred ) in which 01 (one) bottle taken as sample and marked as Exhibit- "A-1".

I ASI Niranjan Sarkar of Khalpara TOP under PS Siliguri beg to report that today i.e. on 07.08.21 while performing special mobile van raid at 07:55 hrs I received a source information that one person namely Arjun Mahato (55/M) S/O Late Laxmi Mahato of New Ganganagar near Noni Babu road, ward No.05, PS- Siliguri, Dist- Darjeeling is selling huge alcohol at Ganganagar near river side under Khalpara TOP without any valid license and documents in higher price than the actual value for his illegal gain. Accordingly I informed the fact to I/C, Siliguri P.S over telephone who directed and instructed me to verify the veracity of the information. Accordingly, myself along with force with lady force left for Ganganagar near river side area, Siliguri to verify the veracity of the information vide Khalpara TOP GDE No - 213, Dated: 07.08.21. After reaching Ganganagar near monibaba road at 08:15 hrs and as shown by the source I found the above noted person is selling liquor secretly to different persons and seeing the Police party the above noted person try to flee away but we managed to intercept him. On being asked she disclosed his identity as mentioned above. During search, I could recover the above noted alcohol from his house. During interrogation she admitted that he is selling alcohol for his wrongful gain. On demand he failed to produce any valid license or documents in support of such business. During local enquiry it has been confirmed that the above noted person is selling alcohol illegally since long. Accordingly, I seized the above noted recovered I.D. liquors under proper seizure list duly packed, sealed and labeled in presence of witnesses and took their signature in the seizure list and labels and also arrested the above noted accused person U/S- 41 Cr.P.C under proper memo of arrest and observing all the formalities of arrest. The entire search and seizure process completed in between 08:20 hrs to 08:40 hrs on 07.08.21.

Under the above noted fact and circumstances, I therefore, pray that a specific case under proper section of law may kindly be started against the above noted arrested accused person namely Arjun Mahato (55/M) S/O Late Laxmi Mahato of NewGanganagar near Noni Babu road, ward No.05, PS- Siliguri, Dist- Darjeeling a for the possessing and selling alcohol illegally and arrange for its investigation.
