I, ASI. Jamirul Haque of Ambari Falakata OP under NJP PS/SPC beg to report that on 06.08.21 in course of mobile van duty vide Ambari OP GDE No- 186 dated on 06.08.21 myself along with force namely (1) C/256 Bibhuti Mahato and NVF/29 Kiran Roy both of Ambari-Falakata OP, Under NJP PS/SPC had been to Canal More, under Ambari Falakata OP. PS. NJP to perform mobile Van duty at 18:55hrs I found the above noted persons were roaming without face mask at that area and violated the Government Order (Lock Down) in c/w outbreak of COVID-19. Accordingly, the above noted persons were detained. On being interrogation they disclosed their identity as mentioned above and further they failed to give any satisfactory answer regarding their movement in that area rather they refuse to comply with direction of the Government Order regarding lockdown in c/w outbreak of Covid-19. Hence I arrested them u/s 41 Cr.P.C after issuing copy of Memo of arrest and inform their ground of arrest.

Therefore I pray before your good office that a specific case under proper section of Law may kindly be started against the above noted accused persons namely (1) Sahajahan Alam (27yrs), S/o. Sahirul Haque of Chopra Das Para, PO&PS. Chopra, Dist-Uttar Dinajpur (2) Santosh Das (32yrs), S/o. Lt. Dwijalal Das of Vill-1 No. Takimari, PO. Milan Pally, PS. NJP, Dist-Jalpaiguri (3). Debraj Chakraborty (31yrs), S/o. Bikash Chakraborty of Jalpaiguri Pandapara, PO. Boubazar, PS. Kotwali, Dist-Jalpaiguri and (4) Biswajit Das (23yrs) S/o. Ratan Das of 1 No. Takimari, PO. Milan Pally, PS. NJP, Dist-Jalpaiguri and arrange for its investigation.
