With your due respect I beg to state that, I, Tapashi Biswas, resident of Krishnanagar, Sambhu Para, Jalpaiguri, want to lodge FIR against my son, named, Chiranjit Biswas and his spouse, named Lina Biswas, his mother-in-law, named, Lipi Sarkar, his brother-in-law Manab Sarkar for beating me and abusing me from several days. This long time domestic violence, was initially raised to local Panchayat but no change in their behaviour, has been observed, even after the mutual consent given by them, in front of Panchayat and I found the property paper of my house is missing from my room. Now, they are asking me to stay out of my house and threatening me to kill myself and the whole incident has been taken place by the influence of my son's in-law house; i.e. Manab Sarkar and Lipi Sarkar.

Therefore, I hereby request you to kindly lodge the FIR and an attested copy of the FIR may kindly be provided to me which will help me for future reference.
