In producing herewith one accused person namely Ram Sarkar (59 yrs) male S/o. Lt. Motilal Sarkar of Kamarvita, PO. Kamarvita, PS-NJP, Dist- Jalpaiguri along with the following seized articles as per proper seizure list:

1. 01(One) Bottle of Royal Stag Blender Whisky Containing 750 ML.
2. 01(One) Bottles Emboss Fine Whisky Containing 750 ML.
3. 01 (one) Bottle Imperial Blue Classic Grain Whisky Containing 750 ML.
4. 05(Five) Packet Officer Choice Deluxe Whisky Pouch Containing 75ML each.
5. 10(Ten) Bottle of Pet Galaxy Boss 60 up County spirit Containing 600 ML each.
6. 09(Nine) Bottles pet Galaxy Boss 60up county spirit Containing 300 ML each.

I, ASI. Sailendra Singh of Ambari Falakata out post under NJP PS/SPC lodged a written complainant against the above noted person to the effect that today i.e. on 06.08.2021 at 16:00 hrs while myself along with force left for Evening Raid Duty Vide Ambari-Falakata OP GDE No. 193 Dated: 06.08.2021 in course of Evening Raid Duty I received an information from my source that one Ram Sarkar (59 yrs) male S/o. Lt. Motilal Sarkar of Kamarvita, PO. Kamarvita, PS-NJP, Dist- Jalpaiguri which is huge amount of liquor illegally for selling the same in the customer for his wrongful gain. Accordingly I informed to O/C Ambari Falakata out post about the information. As per his kind instruction I along with, C/1058 Jayanto Debnath, and CV/01 Joychand Roy proceed to Kamarvita, to work out the information. At 19:05 hrs we reached at the spot, after sometimes being identified by the source our police party held raid at the house of one Ram Sarkar (59 yrs) male S/o. Lt. Motilal Sarkar of Kamarvita, PO. Kamarvita, PS-NJP, Dist- Jalpaiguri and recovered the above noted articles from the possession of above noted accused person namely one Ram Sarkar (59 yrs) male S/o. Lt. Motilal Sarkar of Kamarvita, PO. Kamarvita, PS-NJP, Dist- Jalpaiguri. On demand he could not produce any valid license/documents in support of said liquor. He become a nervous and admitted his guilt before us and stated that he sell the same in the customer since long for his wrongful gain. In presence of witnesses namely 1) Abhijit Majumder S/o. Lt. Ashim Majumder of Ambari-Falakata, Chakiavita, PO. Kamarvita, PS. NJP, Dist-Jalpaiguri and 2) Subash Sarkar S/o Lt. Narayan Sarkar of 9 No. Colony, Ambari-Falakata, PO. Kamarvita, PS-NJP Dist-JPG and I seized the above noted articles from the possession of above noted accused person after preparing proper seizure list and took signature of the accused person and witnesses. The seizure was made between 19:15hrs to 19:40 hrs. I arrested the said person u/s 41 Cr.P.C. and issued Memo of arrest appraising the ground of arrest in presence of witnesses.

I therefore request you a specific case may kindly be started against the accused person namely Ram Sarkar (59 yrs) male S/o. Lt. Motilal Sarkar of Kamarvita, PO. Kamarvita, PS-NJP, Dist- Jalpaiguri under proper section of law.
