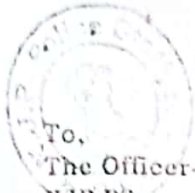

With due respect, I am producing herewith the arrested accused person namely Dasanath Saha (41 yrs) S/O Haran Ch Saha of Goala Busty, Haripur, PS NJP, Dist.- Jalpaiguri under arrest and the following articles under seizure. The ground of arrest duly been enumerated with him.

1. 36 (Thirty six) bottles of 60 up Himalayan Gold Country Spirit containing 300 ML in each bottle of Rs 50/- of each bottle.
2. 08 (Eight) bottles of 60 up Himalayan Gold Country Spirit containing 600 ML in each bottle of Rs 100/- of each bottle.
3. 05 (Five) bottles of Mc Dowels No 1, Luxury Premium Whesky containing 375 Mlo in each bottle.
4. 04 (Four) bottles of HAYWARDS 5000 Super Strong Beer containing 650 ML in each bottle of Rs 150/- of each bottle.
5. 03 (three) bottles of TUBROG Premium Beer containing 650 ml in each bottle of Rs 141/- of each bottle.

I, SI Goutam Mallik presently attached with NJP PS under your kind control beg to state that today i.e. on 06.08.21 at 21.10 hrs I received a secret source information that one person namely Haradhan Saha of Goala Busty, Haripur is selling ID liquor illegally at his residence at Goala Busty, Haripur under PS- NJP, Dist.- Jalpaiguri for his illegal gain. Accordingly, diarized the fact in the General diary vide NJP PS GDE No 302 dated 06.08.21 and informed the fact to you. As per your kind direction and instruction myself along with ASI Khagen Barman, VP/13 Jamirul Islam, VP/08 Laxman Roy and CV/306 Bisawajit Roy left for Goala Busty, Haripur to work out the information in hand. At about 21.35 hrs we arrived at the residence of accused Haradhan Saha at Goala Busty, Haripur and being shown and identified by the source we held raid at his residence and managed to apprehended him. During interrogation he disclosed his identity as noted above and also disclosed that he is selling ID liquor at his residence since long for his wrongful gain. On search the above noted I/D liquor recovered from his possession. On demand he failed to produce any documents/licence in respect of store/sale the I/D liquor found at his residence. Accordingly, I seized the above noted I/D liquor from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search, seizure & arrest was made in between 21.40 hrs hrs to 22.15 hrs on 06.08.21.

Under the above noted fact and circumstances, I therefore pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely Haradhan Saha (41 yrs) S/o Haran Ch Saha of Goala Busty, Haripur, PS NJP Dist Jalpaiguri and arrange for its investigation.
