
1. 15 (f) metal bottles of 60 up Himalayan Gold Country Spirit containing 600 ML in each bottle at Rs. 100/- of each bottle.

SI Goutam Mallik presently attached with NJP PS under your kind control beg to state that today i.e. on 07.08.21 at 22.10 hrs I received a secret source information that one person namely Ram Laxman Mahato of Gowala Busty, South Colony, Dist. Jalpaiguri is selling 1/D liquor illegally at his residence at Goala Busty, South Colony under PS NJP, Dist. Jalpaiguri for his illegal gain. Accordingly, diarized the fact in the General Duty side NJP PS GDE No 364 dated 07.08.21 and informed the fact to you. As per your kind direction and instruction myself along with ASI Khagen Barman, VP/13 Jamnal Islam, VP/08 Laxman Roy and CV/306 Bisawajit Roy left for Goala Busty, South Colony to work out the information in hand. At about 22.25 hrs we arrived at the residence of accused Ram Laxman Mahato of Gowala Busty, South Colony, Dist. Jalpaiguri and being shown and identified by the source we held raid at his residence and managed to apprehend him. During interrogation he disclosed his identity as noted above and also disclosed that he is selling 1/D liquor at his residence since long for his wrongful gain. On search the above noted 1/D liquor recovered from his possession. On demand he failed to produce any documents/licence in respect of store/sale the 1/D liquor found at his residence. Accordingly, I seized the above noted 1/D liquor from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search, seizure & arrest was made in between 22.35 hrs to 23.05 hrs on 07.08.21.




