Sir,
In producing herewith the arrested accused person namely Jayanta Baidya (31 yrs) S/O late Sambhu Baidya of Sri Nagar Colony, PS NJP, Dist.- Jalpaiguri along with the following seized articles under seizure as per seizure list :-

- i) One Packet suspect to be Ganja Containing 8 (eight) Kgs of suspect to be Ganja wrapped with red colour of plastic sheet kept in a marun colour back pack bag marked as Exhibit - "A".
- ii) One Maroon colour bag marked as Exhibit "B".

I, ASI Sajal Das of New Jalpaiguri PS, Siliguri Police Commissionerate, do hereby lodge this written complaint against above noted accused person to the effect that on i.e 07.08.2021 at about 22.25 hrs I received a specific source information that one person namely Jayanta Baidya of Sri Nagar Colony, PS- NJP, Dist.- Jalpaiguri is selling Ganja at his residence at noted above and he stored huge quantity of Ganja at his residence. Accordingly, I informed the matter to SI Samir Tamang, O/C New Jalpaiguri PS, SPC regarding the information in-hand and I diarized the fact in General Diary vide NJP PS GDE No. 365 dated 07.08.21 and as per order myself along with ASI Khagen Barman, C/1053 Patesh Rava, VP/13 Jamirul Islam, VP/08 Laxman Roy, CV/306 Biswajit Roy all of NJP PS left PS for Hospital More by Govt Vehicle to work out the information in hand vide NJP PS MCC No 1534 dated 07.08.21 with necessary articles like white paper, Digital weighing machine, Arrest Memo, Seizure List, seal, gala wax, candles, match box, charger light etc. I find for disinterested witnesses but due to night karfew I did not found any person in the locality to act as witness. At about 22.45 hrs we arrived at the house of accused Jayanta Baidya of Sri Nagar Colony, PS- NJP, Dist.- Jalpaiguri and found one marun colour bag containing suspect to be Ganja kept hidden at the Varanda of his bedroom. Accordingly, the said person was detained after disclosing our identity as police personnel of NJP PS. I told him that as per reasonable information he is stored contraband Ganja inside the bag in his possession. On being asked he disclosed his name and address as noted above. I told him about the information in hand but initially he denied. After prolong interrogation, he confessed that he kept Ganja inside the bag with a view to sale the same for his wrongful gain. Then, I gave him option that whether he wanted to be searched in presence and supervision of Executive Magistrate or police Gazetted Officer. He agreed to be searched in presence of police Gazetted Officer. Accordingly, I served the Notice in writing and as per provision of law to him which he duly acknowledged by receiving and signing in the copy of Notice. Accordingly, I informed Shri Rajen Chhetri, WBPS, ACP, D.D. Siliguri Police Commissionerate regarding the apprehension of said person with said to be Ganja and requested him through messenger to come at Sri Nagar Colony, NJP and remain present as Gazetted Officer during the time of search and seizure if any which he duly accepted. At 00.35 hrs Shri Rajen Chhetri, WBPS, ACP, D.D. Siliguri Police Commissionerate arrived at the spot in uniform and disclosed his identity to the detained person and witnesses as Shri Rajen Chhetri, WBPS, ACP, D.D. Siliguri Police Commissionerate detailed as Special Executive Magistrate, Siliguri Police Commissionerate.

After arrival of Shri Rajen Chhetri, WBPS, ACP, D.D. Siliguri Police Commissionerate I offered the accused person to search me and our Police Party as per provision of law. But he refused to search the police party. Then in presence of Shri Rajen Chhetri, WBPS, ACP, D.D. Siliguri Police Commissionerate the search was started at 01.15 hrs and on being searched one Packet suspect to be Ganja wrapped with red colour of plastic sheet kept in a marun colour back pack bag found in his possession and marked as Exhibit - "A".
