I, SI Sanik Paul of NJP PS Siliguri Police Commissionerate, do hereby lodge this written complaint against above noted accused persons to the effect that on i.e 08.08.2021 at about 00.05 hrs I received a specific source information 8/9 persons are proceeding towards Bangladesh Border with 18/20 cattle with a view to send the cattle to Bangladesh. Accordingly, I informed the fact to O. C. NJP PS and diariized the fact vide NJP PS GDE No 372 dated 08.08.21 and as per his kind order and direction myself along with VP/13 Jamirul Islam, VP/08 Laxman Roy, CV 306 Biswajit Roy left for Joydebvita to work out the information in hand. At 00.35 hrs we arrived at Joydebvita in front of the house of Sayed Ali of Joydebvita and found 09/10 persons proceeding towards Bangladesh with 18/19 cattle in different age size and colour. Accordingly, we the police party managed to apprehended 08 (eight) persons as noted above and 19 numbers of cattle in different size age and colour. On demand they failed to produce any documents in respect of the cattle. On interrogation they admitted their guilt and give different statement in time in regarding the cattle in their possession in the odd time of night. There was sufficient reason to believe that the cattle which were found in their possession are stolen one. Accordingly, I seized 19 (nineteen) numbers of cattle under proper seizure list and arrested them under proper memo of arrest and observing all the formalities of arrest. The search seizure and arrest made in between 01.20 hrs and 02.30 hrs on 08.08.21.


