In producing herewith the Eight arrested accused persons (i) Amiya Ghosh (20), S/O Sushil Ghosh of Khudirampally, PS - BDR, Dist - DJG, (ii) Ahamed Peza (20), S/O Sarafat Ali of Khudirampally, PS - BDR, Dist - DJG, (iii) Sumit Subba (25), S/O Sudhar Subba of Prasad Vila, Bijanbari, Dist - DJG, (iv) Ganesh Roy (31), S/O Arjun Roy of 2 No Takimari, PS - BKN, Dist - JPG arrested u/s 41 Cr.P.C.
