On 03/08/21 17.45h, we received information from Ashikhar Police Station that a woman was found dead at her residence, located at Ashikhar Police Station, Bhaktinagar, P.O. Jalpaiguri. The deceased was identified as Mr. K. M. Sarker, aged 45 years, a resident of Ashikhar Police Station, Bhaktinagar, P.O. Jalpaiguri. The deceased was found lying on the floor of her residence, which is a two-story building. She was wearing a sari and had no visible injuries. Her body was discovered by her husband, Mr. K. M. Sarker, who is a police constable. He reported that he had come home from work and found his wife unconscious. He tried to wake her up but was unsuccessful. He then called the police and an ambulance was sent to the scene. The deceased was pronounced dead at the scene.

Inspector-in-Charge, Bhaktinagar Police Station, Bhaktinagar, P.O. Jalpaiguri, informed us that the deceased was a widow and had been living alone since her husband passed away. She had no children or other relatives living with her. She was known to be a simple person and had no known enemies. Her death is being investigated as a case of suicide.
