31yrs s/o Md Samsad of Asrafnagar, Near Kuti Mill, Ward No-40, PS Bhaktinagar
Dist Jalpaiguri along with seized articles;

1. Two pieces of small 'hp' computer CPU
2. Two pieces of computer Keyboard.
3. Two pieces of computer mouse
4. One black colour EPSON Mini Printer vide model no-M129H along with paper roll & Cable.
5. One White colour EPSON Mini Printer vide SI no-J53G005327 along with paper roll & Cable.
6. Two pieces of small scanner
7. One Parallel Printer cable along with internet adapter.
8. Cash Rs-200 (Two hundred only)
9. Three old plastic chair & one wooden table

I, SI Srimanta Chatterjee of Bhaktinagar Police station do hereby lodge the complaint that today on 03.08.21 at 14.20hrs received source information that since some days one Sardam Hussain & one Sonu are ruining on line one digit lottery at Iskcon Mandir road, Opposite, Kalibari in a room (Shop) with money for their wrongful gain and wrongful loss and may be apprehended with such lottery if responded immediately. Accordingly, the matter was diarised in General Dairy vide GDE No-133 dated 03.08.21 and informing your end, without making any delay, I SI Srimanta Chatterjee, ASI Biswajit Saha, ASI Rabin Lama & CVF/Dharmendra Roy in mufti rushed to Iskcon road.

On way requested two disinterested persons namely (i) Md Rais -31yrs s/o Md Hadish of Asrafnagar Buddha Mandir road, near Kuti Mill, PS Bhaktinagar Dist Jalpaiguri (ii) Mohit Malakar @ Mithun Malakar s/o Lt Ranjit Malakar of Gitalpara, Iskcon Mandir road ward no-40 PS Bhaktinagar Dist Jalpaiguri to stand as a witness to the search and seizure if any.

At 14.35 hrs reached the place at Iskcon road, contacted with the source and keeping the vehicle at a distance started on foot. As pointed by the source cordoned

the shop of Sardam Hussain. On entering shop in presence of the witnesses apprehended the male person noted above and disclosed our identity as police personnel. At then, said person started trembling in panic. On being asked the person disclosed his identity as noted above. Then disclosing our presence at bag shop of Sardam Hussain and following all formalities conducted search of the shop. In the shop the above noted arrested person seating on the seat on which the computer was operating. In the shop the above noted articles could be recovered.

On being asked said Sardam Hussain in respect of such possession, he stated that one Sonu ruining this business of online gambling. He is the staff of those persons. Further he also could not produce any valid papers/License/documents in support of such possession of recovered articles on which are used in on line lottery in exchange of money with playing through internet with a view to wrongful gain and wrongful loss. They are cheated the general public to invest their money on that lottery. They are sells printed on line coupon for the purpose of prize competition.

Accordingly, I prepared seizure list and seized the above noted articles, duly signed by the witnesses and acknowledge by the accused person and arrested the accused Sardam Hussain u/s 41 CrPC (Seizure time 15.20hrs to 16.45hrs).

Under the above, I pray before your kind end to start a case against the above arrested persons namely Sardam Hussain-31yrs s/o Md Samsad of Asrafnagar, Near Kuti Mill, Ward No-40, PS Bhaktinagar Dist Jalpaiguri & one Sonu under proper section of law and caused its investigation.
