Jalpaiguri would like to inform you that, I have entered into the marriage with one Saraswati Das, Daughter of Nripendra Chakraborty, resident of Bhupendra Nagar, Behind Vega Circle Mall, Salugara, P.S Bhaktinagar, Dist. Jalpaiguri on 03.02.2014 according to the Hindu Rites & Customs and after the said marriage my wife Smt. Saraswati Das had given a male child namely Hridhansu Das on 11.06.2017.

I would like to further inform you that today i.e. 03.08.2021 on and from 6 p.m. I found my wife is missing after giving my son to his tuition class and I further came to know that one Bipul Saha, Son of Basu Saha, resident of Sarat Chandra Pally, Haider Para, P.S Bhaktinagar, Dist. Jalpaiguri forcefully kidnap my wife by using some false commitment and I further came to know that the said person i.e. Bipul Saha is a paddler of women and he used to kidnap fool familiar women to use them as prostitute, and he already did same types of incident in earlier with so many girls and woman in his area and from others area and after gathering information I also found the phone number of the said Bipul Saha being no. 9775848804 and 7908815327 and he may fled away with a motorcycle being no. WB 74 AW 362B.

I would like to further inform you that, it is very painful to say that my wife leaving my 4 years old minor son and keeping with her all the gold ornaments worth Rs. 50,000/- and I further found a sum of Rs. 15,000/- is also missing from my locker and it is my strongest believe that said Bipul Saha seduce my wife to carrying the said articles at the time of leaving my house.

Under the above circumstances I would like to request you to find out my wife as early as possible and also punish the said Bipul Saha according to the law for his illegal activities.
