Sir,

In producing herewith one accused person namely Kabin Chhetri-31yrs s/o Lt Dhan Bahadur Chhetri c/o Robin Chhetri of BSF Road, Pipe Line Ward No-42, Salugara, PS Bhaktinagar Dist Jalpaiguri along with the following seized articles as per proper seizure list:

1. 04 (Four) no's of pet Bottles of "BOSS" 60up country sprit (each bottle containing 300ML)
2. 06(six) Bottles of TUBORG strong premium Beer (each bottle containing 650ML)
3. 04(Four) Bottles of Kingfisher strong premium Beer (each bottle containing 650ML)

All the articles containing in one big nylon bag

I beg to report that I, ASI Rabin Lama of Bhaktinagar PS under Siliguri Police Commission lodged a written complainant against one Kabin Chhetri-31yrs s/o Lt Dhan Bahadur Chhetri c/o Robin Chhetri of BSF Road, Pipe Line Ward No-42, Salugara, PS Bhaktinagar Dist Jalpaiguri to the effect that on 04.08.21 at 20.21 hrs while myself along with force performing PS mobile duty received a information from BSF Road, Bikash nagar under Bhaktinagar PS that one person namely Kabin Chhetri of that locality gathered huge quantity of liquor in his street Restaurant at Bikash nagar, B.S.F rd and selling the same in the open market for his wrongful gain without any documents/license. Diarizing the fact in GD vide Bhaktinagar PS GDE No-218 dated 04.08.21. As per-your kind instruction myself with force proceeded to the PO to work out the information. At 21.05 hrs we reached at the locality and sometimes after, being identified by the source our police party held raid and recovered the above noted articles from his possession. During local enquiry it came to learn that he is selling the same in the open market since long for his wrongful gain without any valid documents/license. In presence of witnesses I seized the above noted articles from his possession after prepared proper seizure list and arrested him after maintain all formalities.. (The seizure was made in between 21.20 hrs to 21.45 hrs)

I therefore request you a specific case may kindly be started against the accused person namely Kabin Chhetri-31yrs s/o Lt Dhan Bahadur Chhetri c/o Robin Chhetri of BSF Road, Pipe Line Ward No-42, Salugara, PS Bhaktinagar Dist Jalpaiguri under proper section of law and arrange for investigation
