Respected Madam/Sir,

I, **KHUSHBU KHATOON**, W/O Md. Iqbal, aged about 33 years, both are resident of Dangipara, P.O. & P.S. – Siliguri, Dist. – Darjeeling, do here by beg to inform you the following facts:-

1. That my marriage solemnised on **10-06-2009** as per Muslim Rites and custom by organizing ceremony at Dangipara, P.O. & P.S. – Siliguri, Dist. – Darjeeling and in the said marriage my father gave dowry as per demand of in-laws family members i.e. gold jewellery and all household articles to the in laws family members and after marriage I am residing with my husband and other in-laws family members at Dangipara, P.O. & P.S. – Siliguri, Dist. – Darjeeling.
2. That since from the date of my marriage my husband namely **MD. IQUBAL**, S/O Md. Israil, resident of Dangipara, P.O. & P.S. – Siliguri, Dist. – Darjeeling started torture me both physically and mentally by demanding more dowry from me and force me to bring dowry from my parent and also say that her parent did not give sufficient dowry and demand more dowry from me and on refusal he beated me by fist and blows and by kicks mercilessly by pulling my hair and after that they confine me in a room and do not allow to talk with anyone and also not provide sufficient food to eat due to that I am suffering from starvation and I tolerated all the physical and mental torture with a hope that one day every thing will be alright and I would lead happy conjugal life.
3. That out of the said wed-lock relation between us TWO Girl child was born and the name of younger daughter is **DAFIYA KHATOON BORN ON 05-11-2014** AND another daughter namely **ALIFA KHATOON born on 29-12-2019**
