Sir,

In producing herewith one accused person namely Rajesh Tamang-48yrs s/o Kamal Bahadur Tamang of Kholachand Fapri, Near Tribeni More, PS Bhaktinagar Dist Jalpaiguri along with the following seized articles as per proper seizure list:

1. 11 (Eleven) Bottles of Kingfisher strong premium Beer (each bottle containing 650ML)

All the articles packed in one big nylon bag

I beg to report that I, SI Srimanta Chatterjee of Bhaktinagar PS under Siliguri Police Commissionerate lodged a written complainant against one Rajesh Tamang-48yrs s/o Kamal Bahadur Tamang of Kholachand Fapri, Near Tribeni More, PS Bhaktinagar Dist Jalpaiguri to the effect that on 05.08.21 at 14.45 hrs while myself along with force performing PS mobile duty vide GDE no-266 dated 05.08.21. I received source information from Kholachand Fapri under Bhaktinagar PS that one person namely Rajesh Tamang of that locality gathered huge quantity of liquor in his house for selling the same in the open market for his wrongful gain without any documents/license. As per your kind instruction myself along with force proceeded to the PO to work out the information. At 21.05 hrs we reached at the spot, sometimes after being identified by the source our police party held raid and recovered the above noted articles from his possession. During local enquiry it came to learn that he is selling the same in open market since long for his wrongful gain without any valid documents/license. In presence of witnesses I seized the above noted articles from his possession after prepared proper seizure list and arrested him after maintain all formalities. (The seizure was made in between 21.40 hrs to 22.45hrs)

I therefore request you a specific case may kindly be started against the accused person namely Rajesh Tamang-48yrs s/o Kamal Bahadur Tamang of Kholachand Fapri, Near Tribeni More, PS Bhaktinagar Dist Jalpaiguri under proper section of law and arrange for investigation..
