Sir,

In producing herewith one accused person namely Parimal Barman (21), S/O- Deben Barman Of Iscon Mandir Road, W/No 40, PS Bhaktinagar Dist Jalpaiguri. (C/O Tintal Roy, Back side of Siliguri Club, Baneshwar More, PS Bhaktinagar Dist Jalpaiguri.) and the following articles under seizure

- (1) 15(Fifteen) bottles of "HIMALAYAN GOLD PREMIUM 60 UP COUNTRY SPIRIT" each bottle containing 600 ML, MRP Rs.100/- (Total- 09 Liter & Amount Rs 1500/-).

SI Pradip Kr Singha of Ashighar OP lodged a written complaint against the accused person namely Parimal Barman (21), S/O- Deben Barman Of Iscon Mandir Road, W/No 40, PS Bhaktinagar Dist Jalpaiguri. (C/O Tintal Roy Of Back Side Siliguri Club, Baneshwar More, PS Bhaktinagar Dist Jalpaiguri.) to the effect that, on 06.08.2021 evening as per order of O/C Ashighar OP I along with ASI Krishna Ch Singha C/ 877 Munna Ahmed and CV/1016 Amrit Roy, all of Ashighar OP with Govt. vehicle no WB42/R 8829 were holding raid against anti social elements, warrantees, ID liquor etc in different area under Ashighar OP as per order vide Ashighar OP GDE no. 142 Dt 06.08.2021 in course of which I received information from my source that one Parimal Barman stored a huge numbers of bottles liquor inside his temporary Shop at Baneshwar more and used to sell to the local youth in higher rates. I immediately informed O/C Ashighar OP and as per his kind direction wasting no time I along with my accompanied party left for Baneshwar more area to verify the veracity of information. On the way I called two local person namely (1) Dilip Ghosh (37) S/O Kali Charan Ghosh of Ghugumali PS Bhaktinagar Dist Jalpaiguri and (2) Ajay Sarkar (31) S/O Sunil Sarkar of Niranjana Nagar W/no.36 PS Bhaktinagar Dist Jalpaiguri to accompany us to witness the search and seizure if required. On reaching at Baneshwar More area as indicated by my source I held raid at the temporary Shop of Parimal Barman at Baneshwar more. But seeing us the above noted accused person tried to flee away from the spot, but we managed to apprehend him. I searched in the temporary Shop at Baneshwar more of above noted accused person, in course of which I recovered the above noted bottles of liquor from inside his temporary shop. I seized the above noted articles as alamath of the case, as the above noted person as well as none could be able to produce any documents for such illegal possession of such articles. I also arrest the above noted accused person for violating the provision of B.E Act. The Search and seizure and arrest were made in between 18.35 hrs to 18.50 hrs on 06.08.2021.

Under the above circumstances, I pray to you that a specific case may kindly be started against the accused persons Parimal Barman (21), S/O- Deben Barman Of Iscon Mandir Road, W/No 40, PS Bhaktinagar Dist Jalpaiguri. (C/O Tintal Roy Of Back Side Siliguri Club, Baneshwar More, PS Bhaktinagar Dist Jalpaiguri.) and arrange for its investigation.
