I SI Swapan Kr Ghosh of Ashighar OP under Bhaktinagar Police station, SPC do here by lodge a written complainant against Seven (07) accused persons namely (1) Tushar Sutradhar (18) S/O Taposh Sutradhar Of North Sukantanagar, PO Rabindra Sarani, PS Bhaktinagar Dist Jalpaiguri (2) Rikdev Roy (20) S/O Gopal Roy Of North Sukantanagar, PO Rabindra Sarani PS Bhaktinagar Dist Jalpaiguri (3) Gabinda Paul (19) S/O Prahlad Paul Of Chayan Para Kalisaha More, PS Bhaktinagar Dist Jalpaiguri (4) Koushik Chakrabarty (30) S/O Pulak Chakrabarty Of Hidar Para, W/No 39 PS Bhaktinagar Dist Jalpaiguri (5) Dilip Paul (32) S/O Lt Prabhat Paul Of Teli Para PS Bhaktinagar Dist Jalpaiguri (6) Biswajit Gupta (23) S/O Lt Bimal Gupta Of Rishi Arabinda Road, Hakimpura PS Siliguri Dist Darjeeling (7) Ramkrishna Sarkar (26) S/O Anil Sarkar Of Jabrvita Housing, PS NJP Disr Jalpaiguri, to the effect that today on 06.08.2021 at 15.05 hrs myself along with ASI Krishna Ch Singha C/1181 Bhubesh Ch Roy, and CV/909 Nityananda Choudhury while performing evening patrolling duty in connection with Covid -19 situation at Ashighar OP area vide Ashighar OP GDE no. 142 Date 06.08.2021, at about 16.15 hrs found that the above noted persons were roaming at Ashighar More area without wearing Mask and without any purpose which has been duly promulgated by Government of West Bengal due to crucial situation of corona virus though the Government has abstained them not to come out of the house without any emergency requirement as it is very dangerous for our society at this stage. As Government has announced wearing of facial mask has been made mandatory in public place in current pandemic disaster situation to everybody vide order no. 79-CS/2020 dated 12.04.2020, Vide memo no. 486-CS/2021 dt 24.04.2021 and also announced lock down from 16th may to 31st May vide memo no. 647-ISS/2M-22/2020 DT 15.05.2021 and the same has been extended till 15.06.2021 and order no. 753-ISS/2M-22/2020 DT 14.06.2021 and order no. 753/III-ISS/2M-22/2020 DT 14.07.2021, as it is very dangerous for our society at this stage. However the above persons violated the said rules and norms which has been duty promulgated by Government of West Bengal. Considering the present situation of West Bengal as well as Whole India, I warned them to wear Mask and follow the protocol of COVID-19 & Govt. order but they did not pay heed to my words and did not comply my lawful instructions and kept on roaming within the area without wearing Mask. As such, I arrested them under the provision govt order after observing all sort of rules.

Therefore, I pray before your kind honour that a Specific case may kindly incited against the Seven (07) accused persons namely (1) Tushar Sutradhar (18) S/O Taposh Sutradhar Of North Sukantanagar, PO Rabindra Sarani, PS Bhaktinagar Dist Jalpaiguri (2) Rikdev Roy (20) S/O Gopal Roy Of North Sukantanagar, PO Rabindra Sarani PS Bhaktinagar Dist Jalpaiguri (3) Gabinda Paul (19) S/O Prahlad Paul Of Chayan Para Kalisaha More, PS Bhaktinagar Dist Jalpaiguri (4) Koushik Chakrabarty (30) S/O Pulak Chakrabarty Of Hidar Para, W/No 39 PS Bhaktinagar Dist Jalpaiguri (5) Dilip Paul (32) S/O Lt Prabhat Paul Of Teli Para PS Bhaktinagar Dist Jalpaiguri (6) Biswajit Gupta (23) S/O Lt Bimal Gupta Of Rishi Arabinda Road, Hakimpura PS Siliguri Dist Darjeeling (7) Ramkrishna Sarkar (26) S/O Anil Sarkar Of Jabrvita Housing, PS NJP Disr Jalpaiguri and arrange for its investigation as per proper section of law.
