In producing herewith one accused person namely Sona Kundu (40) S/O Punna Ch Kundu Of Sir. Santinagar Netaji Colony W/No 36 PS Bhaktinagar Dist Jalpaiguri and the following articles under seizure

(1) 30 (Thirty) bottles of "HIMALAYAN GOLD PREMIUM 60 UP COUNTRY SPIRIT" each bottle containing 300 ML, MRP Rs.50/- (Total- 09 Liter & Amount Rs 1500/-)

I SI Pradip Kr Singha of Ashighar OP lodged a written complaint against the accused person namely Sona Kundu (40) S/O Punna Ch Kundu Of Santinagar Netaji Colony W/No 36 PS Bhaktinagar Dist Jalpaiguri to the effect that, on 07.08.2021 evening as per order of O/C Ashighar OP I along with C -877 Munna Ahamed Cv 1016 Amrit Roy, all of Ashighar OP with Govt. vehicle no WB42/R 8829 were holding raid against anti social elements, warrentees, ID liquor etc in different area under Ashigarh OP as per order vide Ashighar OP GDE no. 166 Dt 07.08.2021 in course of which I received information from my source that one Sona Kundu stored a huge numbers of bottles liquor inside his temporary Shop at Santinagar Netaji Colony and used to sell to the local youth in higher rates. I immediately informed O/C Ashighar OP and as per his kind direction wasting no time I along with my accompanied party left for Santinagar Netaji Colony area to verify the veracity of information. On the way I called two local person namely (1) Dilip Ghosh (37) 5/0 Kali Charan Ghosh of Ghugumali PS Bhaktinager Dist Jalpaiguri and (2) Ajay Sarkar (31) S/O Sunil Sarkar of Niranjan Nagar W/no.36 PS Bhaktinager Dist. Jalpaiguri to accompany us to witness the search and seizure if required. On reaching at Santinagar Netaji Colony area as indicated by my source I held raid at the temporary Shop of Sona Kundu at Santīnagar Netaji Colony . But seeing us the above noted accused person tried to fiee away from the spot, but we managed to apprehend him . I searched in the temporary Shop at Santinagar Netaji Colony of above noted accused person, in course of which I recovered the above noted bottles of liquor from inside his temporary shop. I seized the above noted articles as alamath of the case, as the above noted person as well as none could be able to produce any documents for such illegal possession of such articles. I also arrest the above noted accused person for violating the provision of B.E Act. The Search and seizure and arrest were made in between 15.40 hrs to 15.55 hrs on 07.08.2021.

Under the above circumstances, I pray to you that a specific case may kindly be started against the accused persons Sona Kundu (40) S/O Punna Ch Kundu Of Santinagar Netaji Colony W/No 36 PS Bhaktinagar and arrange for its investigation.
