1. That I was married to Sri Tabu Das, S/O - Indra Mohan Das, Permanent resident of Nakarkhana, P.S. - Baxirhat, District - Coochbehar, West Bengal- 736131. *Near-Mantani Kalibari*
2. That when I was at the age of 13 my husband forcefully took me in a room and threatened me that if I refused to marry him then he would commit suicide and also threatened my parents that if they disclose anything to anybody then he will spread fake rumors about my character in the society and will ruin my life and by this way my husband convinced my parents and subsequently in the year of 2013 my parents bound to arrange a marriage between me and Tabu Das.
3. That thereafter the family members of my husband demanded cash dowry as well as gold ornaments and also demanded wardrobe, Dressing Table, Motor Cycle, Watch etc including all the household articles including cash dowry from my father. subsequently as per the demand of the family members of my husband my father has given all the above mentioned articles along with cash dowry of Rs. 2,00,000/- (Rupees Two Lakh Only) and about-5 (Five) bhori gold ornaments to my husband, his parents in presence of the other relatives.
4. That subsequently in the year of 2013 the marriage between me and my husband was solemnized and I started to live in my matrimonial house along with my husband, my father in law namely Indra Mohan Das, my mother in law namely Minu Bala Das, my Brother in laws namely Manik Das and Bablu Das.

5. That on the very next day my mother in law namely Minu Bala Das, W/O. Sri Indra ~~Mohan~~ Das, came to me and demanded all the gold and other gift articles which I received during the marriage ceremony, at that time I was shocked as she said ornaments and other articles belong to me as a Streedhan articles and subsequently I protested the same but my mother in law forcefully took all the gold ornaments including my other Streedhan articles.
6. That from the first day of marriage my in laws were never been happy with me and they used to constantly taunt upon me and let me down in every aspect in the house. My in laws often used to insult me in front of all the family members and neighbors and whenever I tried to protest the same my husband and in laws used to beat me cruelly and used to shut my mouth so that I could not express the matter to anyone.
7. That soon after marriage my husband started to torture me both mentally and physically and pressurized me to bring money from my father and when I refused to comply his demands my husband bang my head on the wall by pouring towel into my mouth so that I cannot scream. Moreover, my husband always used to humiliate me in all respect and in spite of fulfilling all their dowry demands my husband was never happy with me and always used to taunt me as I had brought insufficient dowry. I was treated like a servant form the very beginning and not given the status of a wife. I was bearing all the torture of my husband with a hope that everything will be alright in future but everything was in vein.
8. That on **30.3.2014** my husband and mother in law abused me in most filthy language and even tried to kill me by keeping the gas oven open in the kitchen when I went to make tea in the evening. I was saved due to my own alertness. My husband and mother in law began to abuse and insult me and my family members in front of neighbors and they all took advantage of the fact that I could not express all these in front of my parents or any other family members. Through out of the day I was tortured by my husband and mother in law and at night if I dared to ask my husband for help he used to beat me and accuse me for not bringing enough dowry.
9. That subsequently out of our wedlock one female child namely Shilpi Das was born in the year of 2014. After the birth of my daughter I thought that everything will be alright but all are in vein.

That due to the birth of the female child all my aforesaid in-laws used to abuse me and create mental torture as they expected a male child from me and for that reason my husband never took care of my female child and for the female child my in laws demanded a cash dowry of Rs. 1,00,000/- (Rupees One Lakh Only) from my father and when I refused to fulfill their demand the physical and mental torture increased day by day.
11. That subsequently my husband used to come at home at night in a drunken condition and when I tried to protest to this he caught hold of my hair and pulled me to the kitchen where he poured kerosene oil on me and tried to set me on fire. Some of neighbors came and save me on hearing me cry.
12. That my husband and mother in law used to torture me both mentally and physically and pressurized me to ask my family relatives to give them cash dowry, I was treated like a slave all the time in my matrimonial house and when I protested the same my husband and mother in law used to bang my head on the wall, pouring towel into my mouth so that I cannot scream.
13. That my husband also used to beat me every night and he used to become more furious after taking the weed and alcohol. He used to have forceful brutal sexual intercourse with me and if I scream or try to protest the same or show my unwillingness then my husband used to become more furious and started to put the burning cigarette on my body.
14. That moreover, my husband and above named in laws always used to humiliate me and told me that I am unlucky for them and my in laws very often used to prove me "DAINY", due to such continuous inhuman mental and physical torture I became mentally ruined and depressed and started to live in mental trauma.

I somehow manage to escape from their hands and started to scream so that any neighbor can hear my scream and rescue me. At that time my Parents came and rescued me with the help of the other neighbours but ta that time I could not take my daughter with me.

That subsequently my husband and his other family members came to my parental house and again they started beat me and somehow manage to escape from their hands and I took shelter one of my relatives house on 06.08.2021 namely Krishna Biswas, S/O. Late Fatik Biswas, 33 Lenin Sarani, Bidyachakra Colony, Ward No. 44 of S.M.C., P.S. - Bhaktinagar, District - Jalpaiguri in injured condition and subsequently I visit to a doctor in the Siliguri District Hospital.
17. That after that my husband and other family members came to know my present address and after knowing this they started to threat me and the said Krishna Biswas over telephone from the various phone numbers 1. 8080441770, 2. 8101581441, 3. 6296772991, 4. 9382437335, 5. 9749301346, 6. 8373892266, 7. 7679852913 and they threat me that if I disclose this incident to anyone or take any legal action then they will kill my daughter, my family members and the said Krishna Biswas.
18. That subsequently my husband and his family members along with other anti social persons came to the said Krishna Biswas's house and threat to kill him and his family members.
