Sir,

In producing herewith one arrested accused person namely Bidyut Chakraborty (M-57) S/O-Lt Kalipada Chakraborty of- 1 No Dabgram Colony, Ward No-23, PS Siliguri, Darjeeling along with seized articles (i) 18 (Eighteen) Bottles of 60 UP Country Spirit styled as Himalayan Gold of 600 ml each when packed, MRP Rs. 100/- each (ii) 01 (One) Nylon Bag which used for carrying the seized articles SL.No- 01.

I, SI Arindam Chatterjee of Panitanki TOP under Siliguri PS do hereby lodge a written complaint against the above noted accused person to the effect that today on 07/08/2021 at 11:45 hrs during special raid duty I received secret source information that, one person is selling huge quantity of country spirit at Bidhan Market under Panitanki TOP. Accordingly I informed the information to OC Panitanki TOP and as per his direction I along with ASI Biswajit Ghosh, C/576 Binay Ch Roy left for PG to work out the information. On arrival at Bidhan Market near Sabji Bazar at 11:55 hrs being pointed out by the source, found that one person is selling huge quantity of country spirit containing with a Nylon bag. Accordingly I intercepted the said person with loaded articles in presence of witnesses. On search I recovered 18 (Eighteen) Bottles of 60 UP Country Spirit styled as Himalayan Gold of 600 ml each when packed, MRP Rs. 100/- each (ii) 01 (One) Nylon Bag.

On interrogation he failed to produce any valid documents/license in support of the same and stated that he will sale the same to the local public of Gurung Busty and adjacent area illegally with a view to earn huge money for his lively hood. Accordingly I seized 18 (Eighteen) Bottles of 60 UP Country Spirit styled as Himalayan Gold of 600 ml each when packed, MRP Rs. 100/- each (ii) 01 (One) Nylon Bag which was used for carrying the seized articles under proper seizure list and labeled the same in presence of witnesses and duly sign by them and also by the accused person and arrested him. The seizure was made between 12:05 hrs to 12:15 hrs and arrested the accused person u/s 41 Cr. P.C after explaining charge against him. Total value of seized articles is Rs. 1800/-

Under the above circumstances I am submitting this written complaint against the above accused person namely Bidyut Chakraborty (M-57) S/O-Lt Kalipada Chakraborty for starting a specific case under proper section of Law and to arrange for its investigation.
