In producing herewith arrested accused person namely Barun Biswas (30) S/O Late Kestolal Biswas of Sarbohara Colony, Ward No. 28, PS- Siliguri, Dist- Darjeeling along with seized articles vize- i) 20 (Tweenty) sealed bottles of Himalayan Gold 60 up country spirit containing 600 ml. each labeled as Himalayan Endeavour PVT. Ltd. Siliguri, West Bengal @ Rs 100 each (Amounting of 20 x Rs 100/- =RS.2000/-) as per seizure list.

1, SI Hiru Kanti Sarkar of Siliguri PS, SPC do here by lodged a written complaint against above noted arrested accused person namely Barun Biswas (30) S/O Late Kestolal Biswas of Sarbohara Colony, Ward No. 28, PS- Siliguri, Dist- Darjeeling to the effect that on 07.08.21 at 14.35 hrs acting on secret information, I received a source information that the above noted person was busy to sale Id liquor illegally at his house situated at Sarbohara Colony under Siliguri PS in order to clandestinely dispose the same. Accordingly the fact is diarized in GD vide Siliguri PS GDE no. 449 dated 07.08.21 and informed the fact to I/C Siliguri PS. As per direction of I/C Siliguri PS, I along with CV/283 Prosenjit Dey & CV/622 Ramanath Barman left for Sarbohara Colony under Siliguri P5 to verify the veracity of the information vide Siliguri PS GDE No. 450 dated 07.08.21. On reaching at 14.55 hrs there and as identified by source cordoned the above noted area where he was selling illegal alcohol. On seeing the police party the above noted person tried to escape from the spot but we managed to apprehend the above noted person and on interrogation, the above noted person disclosed his identity as noted above. On searching 20 (Tweenty) sealed bottles of Himalayan Gold 60 up country spirit containing 600 ml. each labeled as Himalayan Endeavour PVT. Ltd.

Siliguri, West Bengal @ Rs 100 each (Amounting of 20 x Rs 100/-=RS.2000/-) which was kept concealed in his house. On being interrogation he could not produce any valid documents in respect of the said liquor. He also stated that he is doing this liquor business since long for wrongful gain. Accordingly I seized the same in presence of witness duly signed by them. The seizure and label was made in between 15.05 hrs to 15.55 hrs. On being asked he stated that he used to sale the same to locality without any valid documents as he has violated the norms of Bengal Excise Act as such I arrested her U/S-41 Cr.P.C after observing all sorts' of rules for selling the said seized articles without any valid license.

Therefore I pray before your honor that a specific case may kindly be started against the arrested accused person Barun Biswas (30) S/O Late Kestolal Biswas of Sarbohara Colony, Ward No. 28, PS- Siliguri, Dist- Darjeeling along with seized articles under proper section of law and arrange for its investigate.
