horror and great shock I found that the gate lock was  
broken open and after entering the room inside someone  
had stolen about Rs 20,000.00 (Rupees twenty thousand) in  
cash kept in two drawers in the office table. This amount

was the contribution/donation of the people to the Church.  
Rs 4,500/- of it was my monthly allowance (of August 2021)  
The room had the look of vandalism.

Also, my mobile SAMSUNG J4 16GB was stolen.  
Its colour was black. I had left it on the table in my room.

I hereby earnestly request you to nab the culprits  
and recover the items mentioned above.
