I, SI Rana Brahma of Panitanki Town out Post, PS- Siliguri, SPC do hereby lodge a written complaint against the above noted accused persons to the effect that on 07.08.2021 at about 19:15 hrs while performing special raid duty at Panitanki More and found the above noted arrested persons were moving here and there without using face mask. On being asked they disclosed their name as (1) Mohanta Manna (59) S/O Haradhan Manna of Basundhara Apartment, Opp. Bhaktinagar PS, PS- Bhaktinagar, Jalpaiguri (2) Pradip Kr. Jha (50) S/O Bharat Kr. Jha, of Katariya, PS- Benipatti, Dist- Madhubani, Bihar (3) Debraj Roy (34) S/O Sunil Roy, of Netali Para (Near Netaji Sporting Club), PS- Bhaktinagar, Jalpaiguri (4) Jitu Roy (55) S/O Teka Roy of Ektiasal, Near Hari Mandir, PS- Bhaktinagar, Jalpaiguri (5) Ashok Kumar Gupta (41) S/O Mohan Prasad Gupta of Milan pally, Ashok Nagar, PS- Bhaktinagar, Jalpaiguri (6) Rabindra Debnath (28) S/O Rajen Debnath of Dubragachh, PO. Rajganj, PS- Rajganj, Jalpaiguri and (7) Bishu Mandal (48) S/O Lt Jagadish Mandal of Adarsha Pally, Ward No-10, Sevoke Road, PS- Siliguri, Dist- Darjeeling.

On interrogation, it could be learnt that they had no any reason to moving here and there without using facial mask during Pandemic disaster situation. Finding no other alternative, I arrested them U/S 41 Cr. P. C as there was no scope to give notice under 41 (A) Cr. P. C. On being asked the above noted persons stated that they were well aware of the Pandemic disaster situation and they were moving here and there without facial mask & valid reason. They negligently and malignantly move to spread infection of any disease dangerous to life during Pandemic disaster situation.

Hence, they violated the order of Govt. of West Bengal duly promulgated in order No. 753/III-ISS/2M-22/2020 and order No-753/II-ISS/2M-22/2020 dated 28/06/2021. The above noted persons have intentionally refused to comply with the order of Govt. of West Bengal duly promulgated in view of break-out of pandemic COVID-19 throughout the country. According I arrested them u/s- 41 Cr.P.C in c/w the case after observing all rules and formalities.

Under the above facts and circumstances I pray that a specific case may kindly be initiated against (1) Mohanta Manna S/O Haradhan Manna (2) Pradip Kr. Jha S/O Bharat Kr. Jha (3) Debraj Roy S/O Sunil Roy, (4) Jitu Roy S/O Teka Roy (5) Ashok Kumar Gupta S/O Mohan Prasad Gupta (6) Rabindra Debnath S/O Rajen Debnath and (7) Bishu Mandal S/O Adarsha Pally and arrange for its investigation.
