Sir,

In producing herewith three (03) arrested accused person namely 1. Dulal Barman (26) s/o Sri Dhiren Barman of Thiknikata near North Bengal Medical College & Hospital Ps Matigara Dist. Darjeeling 2. Subhash Singha (48) s/o Lt. Dharendra nath Singha of Kawakhali More near Kali Mandir Ps Matigara Dist. Darjeeling and 3. Subhankar baidya (30) s/o Sri Chittaranjan Baidya of Kawakhali Bazar near North Bengal Medical College & Hospital Ps Matigara, Dist. Darjeeligg (P/A- Gacha Bazar Ps Nakasipara Dist. Nadia) alongwith following seized articles viz,

- i. One zipper transparent thin plastic packet in contents 35 grms (thirty five) said to be brown sugar , Market as Exhibit -A.
- ii. 10 (Ten) grams of said to be brown sugar which drawn from exhibit-A as sample for examination packed, sealed, labeled and marked as exhibit-A-1.
- iii. One Plastic Hand bag without name & styled marked as exhibit-B.

I, SI Dipankar Chakraborty of Bagdogra Ps , Siliguri Police Commissionerate do here by lodged this complaint against 1. Dulal Barman (26) s/o Sri Dhiren Barman of Thiknikata near North Bengal Medical College & Hospital Ps Matigara Dist. Darjeeling 2. Subhash Singha (48) s/o Lt. Dharendra nath Singha of Kawakhali More near Kali Mandir Ps Matigara Dist. Darjeeling and 3. Subhankar baidya (30) s/o Sri Chittaranjan Baidya of Kawakhali Bazar near North Bengal Medical College & Hospital Ps Matigara, Dist. Darjeeligg (P/A- Gacha Bazar Ps Nakasipara Dist. Nadia) to the effect that on 09.08.21 at 14-35 hrs received a secret source information that three persons having possession huge quantity of brown sugar are standing at Gosainpur More for clandestinely disposal of the same illegally. The matter was diarized vide Bagdogra Ps GDE No-776 dt-09.08.21. Accordingly, I informed the matter to O.C, Bagdogra PS as per his instruction myself along with ASI Jakirul Islam , ASI Madan Rishi , C/410 Montosh Singh, VP- 02 Pradip Roy left for the spot at 14-40hrs to verify the veracity of the information vide corresponding Bagdogra Ps G.D.E. No. 777 dtd and Bagdogra Ps M.C.C No-1664/21 Dt.09.08.21.

At the time of departure from Police Station I bring spring weighing clock, small balance with stone, envelope, paper, sealing wax, gum, seal etc . On way to spot at Gosainpur More meanwhile I called two independent witnesses namely [1] Nirupam Roy (30) s/o Naresh Roy of Gossainpur near overbridge Ps Bagdogra Dist. Darjeeling and 2. Utpal Goswami (43) s/o Lt. Ajoy Goswami of Gossainpur , Natunpara Ps Bagdogra Dist. Darjeeling informed them about the information in hand and requested them to accompany us to witness the search and seizure if necessary. At about 14-55 hrs on arrival there by govt. vehicle as identified by the source we surrounded the place and found three persons were standing at Gosainpur More near Railway Over bridge with Plastic bag in hand, on seeing police party , they try to flee from there and a plastic bag in hand keeps thrown towards each other. On hot chase, we apprehended the three persons with the said plastic bag. On being asked they disclosed their identity as noted above. After disclosing our identity I asked them whether they wanted to be searched in presence of Executive Magistrate or any Gazetted Officer and they agreed to search by any one. I served her option notice accordance with provisions of law in this regard in writing and they also gave her approval of being searched by any one in writing in the notice serve to them. Accordingly I informed the matter to O.C. Bagdogra Ps and he informed me over mobile phone to send one requisition to Sri Pasang Topgay Bhutia ,ACP, Traffic (West), SPC . Accordingly I informed to Sri Pasang Topgay Bhutia ,ACP, Traffic (West), SPC and request to came to the spot. At about 15-35 hrs Sri Pasang Topgay Bhutia ,ACP, Traffic (West), SPC and O.C. Bagdogra Ps arrived at the spot. I disclosed the identity of Sri Pasang Topgay Bhutia ,ACP, Traffic (West), SPC to the accused persons as Gazetted officer and also witnesses. I also

offered the independent witnesses and the accused persons to search our Police Party as per provision of law. But they refused to search the police party. Under supervision of Sri Pasang Topgay Bhutia ,ACP, Traffic (West), SPC and in presence of independent witnesses I conducted searched and recovered One zipper transparent thin plastic packet in contents said to be brown sugar which kept in a Plastic hand bag from their joint possession. On demand in presence of the Gazetted Officer Sri Pasang Topgay Bhutia ,ACP, Traffic (West), SPC they failed to produce any valid document in support of possessing of the same.

I accordingly weighed the recovered said to brown sugar by the weighing instrument and found total 35 grms said to be brown sugar in one zipper transparent thin plastic packet Marked as Exhibit -A and 10 Grams said to be brown sugar taken as sample from the Exhibit -A in one separate thin plastic packet and marked as A-1 and one Plastic bag without any name & styled, marked as exhibit-B . I labeled and sealed all the article in presence of Sri Pasang Topgay Bhutia ,ACP, Traffic (West), SPC and independent witnesses and accused persons. Then I seized the above noted articles under proper seizure list and label duly signed by the above noted witnesses and the Gazetted officer Sri Pasang Topgay Bhutia ,ACP, Traffic (West), SPC and acknowledged by the accused persons. On further asked the apprehend persons confessed in presence of Gazetted Officer Sri Pasang Topgay Bhutia ,ACP, Traffic (West), SPC and other witnesses that they procured the said brown sugar clandestinely as they are addicted to brown sugar and also the purpose of selling in order to earn huge money illegally. Then I arrested the above noted three accused persons u/s- 41 Cr.P.C after observing all formalities of arrest as well as after disclosing the cause of arrest and issued Memo of Arrest .The copy of seizure list and Memo of Arrest has been supplied to above noted accused persons under proper receipt as the accused persons violated the terms and condition of NDPS Act . The seizure and arrest was made between 15-45 hrs to 16-25 hrs

Under the above circumstances, I pray to you that a specific case under proper section of Law may kindly be started against the accused persons namely 1. Dulal Barman (26) s/o Sri Dhiren Barman of Thiknikata near North Bengal Medical College & Hospital Ps Matigara Dist. Darjeeling 2. Subhash Singha (48) s/o Lt. Dharendra nath Singha of Kawakhali More near Kali Mandir Ps Matigara Dist. Darjeeling and 3. Subhankar baidya (30) s/o Sri Chittaranjan Baidya of Kawakhali Bazar near North Bengal Medical College & Hospital Ps Matigara, Dist. Darjeelign (P/A- Gacha Bazar Ps Nakasipara Dist. Nadia) and arrange for its investigation.
