In producing herewith two arrested accused persons namely i)Dipak Paul(37) s/o-Lt Debendra Nath Paul of New Palpara,Netaji Sarani near Mahamaya Sporting Club,W/N-39 PS-Bhaktinagar Dist-Jalpaiguri and ii)Ganesh Saha (31) s/o-Lt Gopal Ch Saha of Purba Vivekanandapally,Rajarammohon Roy Road ,W/N-38 PS-Bhaktinagar Dist-Jalpaiguri A/P-Madhya Chayanpara,Gopla Ghosh more,w/n-37 PS-Bhaktinagar Dist-Jalpaiguri along with seized items as follows;

- i) 09 Cartoons of **ONEREEX** Cough Syrup containing 144 bottles each. Each bottle contains 100 ml which contains mixture of **10mg Codeine Phosphate & Chlopheniramine Maleate syrup 4mg**, having batch No. TBHU0985 Manufactured by Three B Health Care Ltd, opp Dental College, Rampur road Paonta Sahib, Dist.- Sirmour ( H. P. ) – 173025, ( Total bottles 1296 Pieces ) Each bottle MRP RS. 144.90/- and marked as **Exhibit-A,B,C,D,E,F,G,H,I** and randomly taken one bottle from each cartoon as sample marked as **Exhibit-X**
- ii) **One cartoon of SPASMO-PROXYVON PLUS** capsules, Btch no-WAA1069 Manufactured by Akums Drugs & Pharmaceuticals Ltd, **Quantity (70x18x8 capsules=10080 capsules)** marked as **Exhibit-J** and taken as sample one packet quantity (18x8=144 capsules) marked as **Exhibit-J1**.

I SI Biswajit Ghosh of Detective Department, SPC, Siliguri lodge a written complaint to the effect that on 07.08.21 received a reliable source information that the above noted accused persons are storing and selling cough syrup and Capsules at garage cum godown of Manik Banerjee Sarani, Rabindra Nagar, w/n-21 PS-Siliguri Dist-Darjeeling to the drug addicts at higher prices without prescriptions for their wrongful gain .I diarized the same vide DD,SPC GDE No. 41 Dt: 07.08.21 and informed ACP, DD ,SPC . Accordingly on his consent myself along with SI Swadesh Saha, SI Mrityunjoy Roy, Const- 562 Utpal Saha and Const. 1054 Arobindu Roy and team of SOG SPC left for Manik Banerjee Sarani, Rabindra Nagar, w/n-21 PS-Siliguri Dist-Darjeeling vide DD,SPC GDE No 42 Dt:07.08.21 and CC No 239/21 Dt: 07.08.21 to work out the information. At the time of departure from the office, I took envelope, white paper, sealing wax, gum, seal, official stamp, stamp pad and all necessary requirements.

At about 21.05 hrs, we arrived at said garage cum godown as indicated by the source and in presence of local witnesses namely (1) Bikash Das S/O Lt Phanibhusan Das (2) Tirthankar Das S/O Bikash Das and (3) Subhankar Das S/O Bikash Das all of Manik Banerjee Sarani, Rabindra Nagar, w/n-21 PS-Siliguri Dist-Darjeeling , entered there and found the above mentioned two persons were arranging several cartoons which were supposed to be taken out of the godown. The two persons present inside the godown being asked to identify themselves disclosed the names as namely i)Dipak Paul(37) s/o-Lt Debendra Nath Paul of New Palpara,Netaji Sarani near Mahamaya Sporting

Club, W/N-39 PS-Bhaktinagar Dist-Jalpaiguri and ii) Ganesh Saha (31) s/o-Lt Gopal Ch Saha of Purba Vivekanandapally, Rajarammohon Roy Road, W/N-38 PS-Bhaktinagar Dist-Jalpaiguri A/P-Madhya Chayanpara, Gopla Ghosh more, w/n-37 PS-Bhaktinagar Dist-Jalpaiguri. On being asked to justify about their presence in the said godown with those packed cartons, they could not give any satisfactory answer and confessed that those packed articles were drugs which were obtained fraudulently from some where with intension to sell at Siliguri and surrounding areas illegally for their wrongful gain. On demand they failed to produce any documents to support the possession of said drugs.

We then detained them and asked them whether they wanted to be searched in presence of Executive Magistrate or Gazetted Officer and they agreed to be searched by any one of them. Then I called Sri Manabendra Sekhar Rakhsit, ACP Traffic(HQ), SPC as a Special Executive Magistrate to attend at the spot for search and seizure. At 22.15 hrs Sri Manabendra Sekhar Rakhsit, ACP Traffic(HQ), SPC appeared at the spot and gave the identity as executive magistrate before detained persons. Then I searched the godown and found i) 09 Cartoons of ONEREEX Cough Syrup containing 144 bottles each. Each bottle contains 100 ml which contains mixture of 10mg Codeine Phosphate & Chlorpheniramine Maleate syrup 4mg, having batch No. TBHU0985 Manufactured by Three B Health Care Ltd. opp Dental College, Rampur road Paonta Sahib, Dist- Simour ( H. P. ) - 173025, ( Total bottles 1296 Pieces ) Each bottle MRP RS. 144.90/- and marked as Exhibit-A,B,C,D,E,F,G,H,I and randomly taken one bottle from each cartoon as sample marked as Exhibit-X and ii) One cartoon of SPASMO-PROXYVON PLUS capsules, Btch no-WAA1069 Manufactured by Akums Drugs & Pharmaceuticals Ltd, Quantity (70x18x8 capsules=10080 capsules) marked as Exhibit-J and taken as sample one packet quantity (18x8=144 capsules) marked as Exhibit-J1.

It is seen that all the articles found as mentioned above are prescription drugs which falls under NDPS Act and liable for punishment as per its provision. I seized all the above articles in separate and proper seizure list in presence of the witnesses who were accompanying us with proper sealing and labeling which was seized from the joint possession of the above mentioned both accused persons. The articles seized are psychotropic substance which is used by the Drug abusers for intoxication. Hence having strong reason to believe that they were committing the offence under NDPS Act I, arrested them by preparing arrest memo and took them under my custody. The seizure was made in between 22.20 hrs and 23.50 hrs. On further interrogation they also confessed they along with few others are running this business illegally.

All the accused persons have committed the offence under NDPS Act and liable for punishments as per its provision.

Hence a specific case may kindly be started against both the arrested persons as mentioned above and others and arrange for its investigation.
