Sir,

In producing herewith three ( 03 ) accused Ladies namely (1) Smt. Kanchan Mondal (35) W/O Bindeswari Mondal of Athgama, PO. Akidatpur, PS. Kharik Bazar, Dist- Bhagalpur, Bihar, (2) Smt. Fuldebi Mondal (40) W/O Ganga Mondal of Kazikuriya, PO. Akidatpur, Dist- Bhagalpur, Bihar, (3) Smt. Renu Devi Bhagat (40) W/O Manoj Bhagat of village Khayerpur, PO Khayerpuri, PS Kharik, Dist- Bhagalpur, Bihar under arrest along with seizure list with following seized articles:-

- (1) 2.195 kg (two kgs one hundred ninety five grams except bag ) inside a black bag which was carried by Kanchan Mondal (35) marked as Exhibit- "A"
- (2) 2.300 kgs (two kgs three hundred except bag ) of said to be ganja kept concealed inside a green colour bag which was being carried by accused Fuldebi Mondal (40) marked as exhibit "B".
- (3) 3.190kg (three kgs and one hundred ninety grms except bag ) said to be ganja kept concealed in a brown colour bag carried by Renu Devi Bhagat (40) marked as exhibit- "C"
- (4) 50 grams of said to be ganja extracted from exhibit A for examination and marked as Exhibit A-1.
- (5) 50 grams of said to be ganja extracted from exhibit B for examination and marked as Exhibit B-1.
- (6) 50 grams of said to be ganja extracted from exhibit C for examination and marked as Exhibit C-1.

I PSI. Kalyan Saha of Pradhan Nagar PS, SPC would like to lodge this written complaint against the above noted accused person who had been arrested for contravening the norms of NDPS Act to the effect that today on 07.08.21 at 13:10 hrs myself received a secret source information that three ladies is waiting for Bihar going bus at Bihar Bus Stand near Siliguri Bus Terminus under Ps Pradhan Nagar with a huge quantity of Ganja in their possession kept concealed in three bags with a view to transport and sale the same in Bihar procured from coohbehar side they could be caught red handed, if apprehended immediately. Wasting no time I diarized the information to Pradhan Nagar PS GDE NO- 471 Dated 0708.21 and consequently informed the tip off to you for kind instruction. Subsequently on being directed, myself along with, ASI. Ratan Pradhan, L/C 720 Mithu Kabiraj, L/C 1269 Pramila Chetri, L/C 1280 Bhakta Kumari Gurung, CV/223 Swapan chettri and CV/242 Rakesh Mangar left PS along with investigating kits i.e, the weighing articles, envelope, gum, seal etc from Pradhan Nagar PS at 13:15 hrs for perusing the information by Govt. Vehicle bearing regd. no. WB 74 AC 9851. This refers to Pradhan Nagar PS GDE No- 472 Dated 07.08.21, under this circumstance any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender. While going to near Siliguri Junction Traffic Guard under Pradhan Nagar Ps we stopped and contacted two persons namely: (1) Suraj Sha (20) S/O Sumit Sha of Rajender Nagar Colie Para, Ps. Pradhan Nagar, ii) Pankaj Yadav (18) S/O Munna Yadav of Coolie para near Samshan Ghat, Ps. Pradhan Nagar/Djg, and make them aware of the information in hand and requested them to act as witnesses if any search and seizure would be made necessary upon which they agreed and I gave them notice in this regard. Thereafter we along with the independent witnesses reached at Bihar Bus Stand near Siliguri Bus Terminus at 13:25 hrs.

On reaching there I contacted with my source and subsequently being pointed by my source cordoned off three ladies near Bihar Bus Stand near Siliguri Bus Terminus under PS Pradhannagar. Thereafter we disclosed our identity and the information in hand and stated them that they will be searched in person for the purpose. As the odour of ganja was coming out from those bags which was possessed by them, there was enough reason to believe that the article inside the those bags were ganja. Subsequently on being asked they disclosed their identity as noted above and thereafter, I gave them the written option to be searched before a Magistrate or a Gazetted Officer upon which they agreed to be searched before a gazetted officer. Consequently I contacted with I/C Pradhannagar PS Sri Subhasish Chaki and stated him about the incident and requested him to be present at the spot as Gazatted officer.



of ganja was coming out from those bags which was possessed by them, there was enough reason to believe that the article inside the those bags were ganja. Subsequently on being asked they disclosed their identity as noted above and thereafter, I gave them the written option to be searched before a Magistrate or a Gazetted Officer upon which they agreed to be searched before a gazetted officer. Consequently I contacted with I/C Pradhannagar PS Sri Subhasish Chaki and stated him about the incident and requested him to be present at the spot as Gazetted officer for supervising search and seizure in presence of witnesses. Sri Subhasish Chaki, I/C PDM PS arrived at the spot at 13.45 hrs and thereafter the process of the search was conducted. Before conducting the search self search of mine and Sri Subhasish Chaki had been conducted by the witnesses. Subsequently on being searched from three bags of the above noted accused persons said to be ganja could be recovered as (i) 2.195kg (two kgs one hundred ninety five gms except bag ) inside a black bag which was carried by Kanchan Mondal (35) marked as Exhibit "A" (ii) 2.300 kgs (two kgs three hundred except bag ) said to be ganja kept concealed inside a green colour bag which was being carried by accused Fuldebi Mondal (40) marked as exhibit "B" (iii) 3.190kg (three kgs and one hundred ninety gms except bag ) said to be ganja kept concealed in a brown colour bag carried by Renu Devi Bhagat (40) marked as exhibit "C". Thereafter I weighted the ganja recovered from the accused persons which stands total 7.685 kgs. Thereafter I seized the recovered Ganja of 7.685 kgs under proper seizure list duly signed by the accused persons and witnesses. The seizure was made in between 13.45hrs to 14.50hrs. In the seizure list I obtained the signature of three accused persons, Sri Subhasish Chaki I/C Pradhannagar PS as gazetted officer, witnesses and put my signature too. The mother packets have been labeled as "A", "B", "C", and took out samples of 50 grams from mother packet as sample packet marked as "A1", "B1", "C1" respectively. Consequently the apprehended persons had been arrested issuing Arrest Memo for contravening the norms of NDPS Act keeping their modesty by the ladies police and returned back to Pradhan Nagar Ps.

On the above circumstance, I pray before you to start a specific case against the above noted accused person namely (1) Kanchan Mondal (35) W/O Bindeswari Mondal of Athgama, PO. Akidatpur, P's Kharik Bazar, Dist- Bhagalpur, Bihar, (2) Fuldebi Mondal (40) W/O Ganga Mondal of Kazikuriya, PO. Akidatpur, Dist- Bhagalpur, Bihar, (3) Renu Devi Bhagat (40) W/O Manoj Bhagat of villege Khayerpur, PO Khayerpuri, PS Kharik, Dist- Bhagalpur, Bihar under proper section of law and arrange for its investigation.
