Sir,

In producing herewith one accused person namely Neema Dorjee Tamang (29), s/o-Basant Tamang, Mandi Bazar, Rangpo, East Sikkim(not verified) in custody and the following property under seizure along with seizure list:-

- i. One carton containing "ONEREEX" Cough syrup of Escape Pharmaceutucial, Vikash Nagar, Deradun(UK) containing total 144 bottles each bottle contain 100 ml. in the said cartoon and marked as exhibit-"A",
- ii. 02(two)bottles of "ONEREEX" Cough syrup, Escape Pharmaceutucial, Vikash Nagar, Deradun(UK) taken randomly from exhibit-"A" as sample, and Marked as exhibit-"A-1"
- iii. One carton containing "Spasmo-Proxyvon plus" capsules of marketed by Workhard Limited, containing 70(seventy) packets and each packet contain 06(six) strips and each strips containg 24(twenty four) capsules marked as exhibit-"B",
- iv. 10(ten)strips of "Spasmo-Proxyvon plus" capsules of marketed by Workhard Limited randomly taken from exhibit-"B" as sample, and Marked as exhibit-"B-1",
- v. One Tata Sumo Gold vehicle bearing no- SK- 04-J-1015 white colour inside which exhibit "A" & "B" was kept marked as exhibit-"C".

I, SI Rash Bihari Saha of Special Operation Group, SPC do hereby lodged this complaint to the effect that on 07.08.2021 at 16.05 hrs I received a secret source information that one vehicle bearing no- SK 04- J -1015 (Tata Sumo Gold) was coming from Siliguri Rabindranagar side who carry huge quantity of contraband Drugs in his vehicle, and will heading towards Sikkim via Regulated Market for selling to the same to his designated customer at a high price. Accordingly I informed the matter to Sri Rajen Chettri, Asst. Commissioner of Police, Detective Department, SPC in writing for his kind information and providing police assistance. vide Detective Department, SPC GDE No. 38 Dtd. 07.08.2021. As per kind order of Sri Rajen Chettri, Asst. Commissioner of Police, Detective Department, SPC myself along with ASI Binod Jha, ASI Abu Taleb, C/126 Satrughna Sen, C-166 Gopla Saha, C- 1054 Arabinda Roy C-722 Abhijit Chandra, C-562 Utpal Saha, C-682 Sk. Sabrati, CV-123Ratul Bhattecharjee, CV-145 Vijay Das left for regulated market area under PS- Pradhannagar by govt. vehicle WB-61-A-0137 driven by CD-598 Shibu Das vide Detective Department, SPC vide C.C No- 238 Dt. 07.08.21 to verify the veracity of information corresponding Detective Department, SPC GDE No. 39 Dtd. 07.08.2021. At the time of departure from Detective Department, SPC I took along envelope, white paper, sealing wax, gum, seal, investigation kit etc. On reaching at Regulated market entry gate, at about 16.35 hrs, I called two disinterested witnesses from the spot who were present & available there at that time namely (i) Lalan Sha(50), s/o- Lt. Baijnath Sha of Shibnagar, Darjeeling more, PS- Pradhannagar, Dist- Darjeeling and (ii) Kamal Saha(38), s/o- Shyamal Saha of Ambikanagar, Road no-2, PS- NJP, Dist- Jalpaiguri who were present there and disclosed the matter regarding our information. I also requested them by issuing a written letter for their Consent to accompany us in the whole process during search and seizure if necessary, and obtain necessary permission of their presence as witnesses in the entire process of Search and Seizure under relevant provision of law as witness.

At about 16.55, on being identified by the source, we found one vehicle bearing registration no- SK 04- J -1015 (Tata Sumo Gold) was coming from Darjeeling more side.

We detained the above noted vehicle along with the driver. We disclosed him our identity as police personnel. On being asked he disclosed his identity as noted above. On further examination the above alleged person stated that he was carrying contraband Drugs in his vehicle. Then I asked him whether he wanted to search in presence of Executive Magistrate or any Gazetted Officer and he agreed to search by any one. I served him a notice in accordance with provisions of law in this regard, and obtained his written consent. I

also offered the independent witnesses and apprehended person to search our Police Party as per provision. Accordingly, I also informed the matter to ACP, Traffic(HQ), West, SPC Sri Manabendu Sekhar Rakshit and requested him to present at the spot, as to day he is detailed as Special Executive Magistrates ,SPC. Accordingly at about 17.35hrs ACP, Traffic(HQ), West, SPC Sri Manabendu Sekhar Rakshit arrived at the spot, and disclosed his identity as ACP, Traffic(HQ), SPC and that he is the designated Executive Magistrate of SPC today .

Thereafter under the direct supervision of ACP, Traffic(HQ), (Spl Executive Magistrate)SPC Sri Manabendu Sekhar Rakshit and in presence of independent witnesses I conducted search of the above apprehended person and his vehicle and found One carton containing "ONEREEX" Cough syrup of Escape Pharmaceutucial, Vikash Nagar, Deradun(UK), and One carton containing "Spasmo-Proxyvon plus" capsules of marketed by Workhard Limited, which he carrying inside his vehicle.

On being asked he further confessed in presence of Gazetted officers and other witnesses that he collect the Caught Syrup and Spasmo ProProxyvan Plus Capsules from one Dipak of Rabindranagar. Siliguri for the purpose of selling to his designed Customers of Hill areas in order to earn huge amount of money for his wrongful gain. On interrogation he disclosed that he has been dealing in such illegal drugs for last one year and selling the same to the adjacent area of Kalimpong, Sikkim Hill area with the help of his associates. On examination of the alleged apprehended person noted above failed to produce any documents or license in support of possession of the contraband substance that he was carrying.

Then as per direction of ACP, Traffic(HQ), (Spl Executive Magistrate)SPC Sri Manabendu Sekhar Rakshit, I counted the cartoons "ONEREEX" Cough syrup of Escape Pharmaceutucial, Vikash Nagar, Deradun(UK) containing total 144 bottles each bottle contain 100 ml, marked as as Exhibit "A". 02(two)bottles of "ONEREEX" Cough syrup, Escape Pharmaceutucial, Vikash Nagar, Deradun(UK) taken randomly from exhibit- "A" as sample, and Marked as exhibit-"A-1" and One carton containing "Spasmo-Proxyvon plus" capsules of marketed by Workhard Limited, containing 70(seventy) packets each packet contain 06(six) strips and each strips containg 24(twenty four) capsules marked as exhibit-"B", 10(ten)strips of "Spasmo-Proxyvon plus" capsules of marketed by Workhard Limited randomly taken from exhibit-"B" as sample, and Marked as exhibit-"B-1",



Then I seized the articles under proper seizure list under the supervision of ACP, Traffic(HQ), (Spl Executive Magistrate)SPC Sri Manabendu Sekhar Rakshit in presence of witnesses duly signed by them as well as the accused person and sealed and labeled the said exhibits.. The whole process of seizure was made between 17.55 hrs to 19.15 hrs. Then I arrested the above noted accused person u/s- 41 Cr.P.C after observing all formalities of arrest and informed him the grounds of arrest, issuing Memo of Arrest. The copy of seizure list and Memo of Arrest were supplied to above noted accused person under proper receipt. The accused person violated the terms and condition of N.D.P.S Act possessing contraband Drugs without any lawful documents.

Under the above circumstances, I pray to you that a specific case may kindly be started against the accused person namely Neema Dorjee Tamang(29), s/o-Basant Tamang of Mandi Bazar, Rangpo, East Sikkim(not verified) and Dipak of Rabindra Nagra and arrange for its investigation.
