Sir,

I, Ankita Guha, wife of Samrat Chakraborty, residing at Rathkhola, Matangini Hazra Road, Radhika Apartment 1<sup>st</sup> Floor , Flat No: 1/F, P.O. Siliguri, P.S.- Siliguri, District Darjeeling, PIN Code- 734006, would like to inform you that I got married to Samrat Chakraborty, son of Late Asit Chakraborty, presently residing at Matingini Hazra Road, Rathkhola, behind Renuka Bhawan, P.O.- Rabindra Sarani, , P.S.- Siliguri, District- Darjeeling- 734006 (W.B.), on 3<sup>rd</sup> December, 2017 as per Hindu rites and customs. That after marriage I started to live with my husband at Radhika Apartment 1<sup>st</sup> Floor, Flat No: 1/F, as per the instruction of my in-laws. That the relation between us was good earlier, but when I gave birth to two special children (who required special attention and care) and there was lot of expenses behind them, my husband and mother-in-law namely, Sudha Chakraborty (resident of Matingini Hazra Road, Rathkhola, behind Renuka Bhawan, P.O.- Rabindra Sarani, P.S.- Siliguri, District- Darjeeling- 734006 (W.B.)), and sister-in-law namely, Monalisa Roy wife of Dr Partha Pratim Roy, (resident of house named SHRI at Subhaspally, Siliguri), started to torture me by using abusive language against me saying that I am unable to give birth to a normal child. That my husband used to criticise me by saying that I have brought two extra burdens in the house. That my husband also started troubling me in manifold ways over the issue of increased expenses by reason of my special children and asked me to bring money from my father for meeting up the extra financial burden caused by my inability to give birth to physically fit children . The torture and harassment by my husband and in laws was so intense that at one point of time I thought of ending my life but could not do so for the sake of my children. That gradually, my husband started to ignore my existence and he used to remain busy in lascivious discussion over phone during nights which had obliterated my inner peace. My husband began to torture me and ultimately compelled me to sell my land by putting me under threat that he will not bear the expenses of my children if I do not listen to him. That subsequently, my husband compelled me to purchase a *Toyota Fortuna Car* for his luxury and showmanship, by using some of the ~~consideration amount~~ of my land and instalments of the car are being auto-debited

That I was waiting for my husband to come back and so I did not lodge complaint immediately. That meanwhile I received a divorce petition. I tried to contact my husband but my husband did not receive my calls.

That on 6<sup>th</sup> July 2021 at 9.30 pm, I went to my mother-in-law's house as I heard that my husband had come back and was staying there. That when I entered my mother in laws house I found my husband there and asked him as to why had he abandoned me and my children. However, my husband asked me to leave the house. But I refused as my husband was not paying any maintenance for my two special children. That my husband called his sister namely, Camelia Saha and she came immediately and they all started using abusive language against me and asked me to leave the house. That subsequently, through police intervention I could enter my shared household at Radhika Apartment 1<sup>st</sup> Floor, Flat No: 1/F with my two children. Since then I have been receiving various threats from every corner to vacate the shared household or else I have to bear dire consequences including loss of life.

That today on 8/8/2021, at around 2.35 pm when I was returning to my shared household after attending a puja ceremony suddenly a bike came and hit my scooter from behind as a result I feel down and the said biker immediately fled away from there by giving out a threat "flat char nahole more jabi". That I suffered bodily pain and was taken to hospital by my father and one uncle.

I therefore request you to take necessary action against my husband, mother-in-law namely, Sudha Chakraborty, two sister-in-law namely, Camelia Saha, Monalisa Roy and husband of Monalisa Roy namely, Partha Pratim Roy.
