Dear Sir,

With due respect I, Reshama Gupta, Wife of Anand Gupta, resident of Gupta Building, Opposite- Central Bank of India, Ward No.- 11 of S.M.C., P.O. Siliguri, P.S. Siliguri, District – Darjeeling, would like to state the following facts -:

1. That I got married with Anand Gupta in the year 2000 and thereafter I started living in a join family with the family members of my husband in the above mentioned address.
2. That after few years of my marriage, my in-laws namely Deodutt Gupta, Son of Late Ramashankar Gupta(Kaka Sasur), Kusum Gupta W/O- Deodutt Gupta (Kaki Sasuri), Ashok Gupta, Son of Late Ramashankar Gupta(Kaka Sasur), Pushpa Gupta W/O- Ashok Gupta (Kaki Sasuri), Narayan Gupta, Son of Late Ramashankar Gupta(Kaka Sasur), and Mira Gupta, W/O- Narayan Gupta(Kaki Sasuri) all of them are resident of Gupta Building, Opposite- Central Bank of India, Ward No.- 11 of S.M.C., P.O. Siliguri, P.S. Siliguri, District – Darjeeling and living in the same premises started torturing me physically and mentally as because I am a Nepali married in a Non-Nepali family.
3. That due to some financial crisis I started a Momo Shop in the ground floor of the same house where I along with my in-laws reside. From the very first day of opening my shop my in-laws were against such

business as because it was 'culturally' not permitted in the family. They always create disturbances in the smooth running of my business.

4. That today on 11/08/2021 at around 10:30 am when I went to open my shop with my staff namely Ajit to open my shop, the above named in-laws suddenly came to the shop and asked me to close the shop, on denial of which Narayan Gupta manhandled me forcefully and Deodutt Gupta pulled my hair and other in-laws attacked me with fist and blow thus outraging my modesty.
5. That thereafter I made hue and cry and the local residents came to my rescue. The above named in-laws while leaving the shop threatened me with dire consequences and told me they would not allow me to run such Momo business in the premises and they would throw me with my family members from the said house if I continue the business.

Sir, I therefore request your good self to investigate into the matter and to take necessary action against them. Thereby I shall be highly obliged to you.
