Sir,

I, Sushmita Sharma D/O Surendra Sharma aged above 22 years R/O Prakash Nagar, Sahani Busty W.No 43 of SMC is bringing this compliant before you that my guardian Mr.Surendra Sharma and Mrs.Laxmi Sharma were not present at our residential premises at around 8.15 pm Mr. Monoj Sahani, Mr. Anurag Sahani and Mrs Jyoti Sahani, Mr Rajesh Sharma, Mr.Mukesh Sharma, Mr.Sudhir Sharma, Mrs. Suraj kala Sharma, Mrs .Pooja Sharma, Mrs. Kunti Sharma all being a resident Prakash Nagar, Sahani Busty W.no- 43 of SMC forcefully entered our residential premises in totally drunk condition and grievously attacked me, my brother in -Law Amit Sharma, My Brother Sahil Sharma, My elder sister Nisha Sharma and my sister infant child named Annika Sharma grievously and the prime accused Mr.Monoj Sahani and Mr. Rajesh Sharma in Possession of Alcohol tried to outrage my Modesty and fiercely attacked my family taking advantages of the situation that my parents were not present at my residential premises while attacking my family they got so force full attacked my family taking advantage of the situation that my parents were not present at my residential premises.

While attacking my family they got so forceful that they even tried to hurt my sister infant daughter .That the accused person were following my brother, they moved out of my residential premises and the moment they saw that my Parents went out of my house they attacked me .My brother in Law, My Sister, and my Sister infant child without any reasons . They have been threatening my father Mr. Surendra Sharma and my mother that they will not allow us to live peacefully at our residential premises and they have threatened us by saying that they will burn our shop as well as they have tried to kill my family members too. Today itself the moment they saw that my guardians are not at our residence they entered our premises attacked us fiercely and they also said while leaving that " this is a warning for your parents, next time we will make sure, you all are either serious hurt or dead" day by day the situation is becoming worst and we are living at our premises on immense fear because we don't know what will happen next second.

So, I Sushmita sharma request before your authority to take necessary action against them.
