I, Sahaj Khatun, W/o SK Momin, D/o Samshed Ali resident of Dhaknatakbari, Champasari, P.O.- Champasari, P.S.-Pradhan-Nagar, Dist-Darjeeling, would like to inform you that on 19-3-2021 my marriage was solemnized with SK Momin @ Ali, a Nizul Hindu, permanent resident of Jangle Sufi, Borhal, Satraran, Hoogly, presently residing at C/o Ajay, Limbu Busty, SMC Ward No.-42, P.O.-Saluguri, P.S.-Bhaktinagar, District-Jalpaiguri according to Muslim rites and customs at my parental house at Dhaknatak, Champasari, P.O.- Champasari, P.S.-Pradhan Nagar, Dist-Darjeeling. At the time of marriage, my parents have given valuable gold ornaments and Silver ornaments worth Rs. 1,00,000/-, entire utensils, alongwith valuable clothings, watch and electronic items and cash money mounting to Rs. 80,000/-. After 8 day of my marriage, the said SK Momin started demanding Pulser 220 Motor Cycle which costs about 1,40,000/- and when I have denied on the pleading of the financial condition of my parents, has started his mental and physical torture upon me. Subsequently he started coming late in night in drunken condition and without any authentic reason he used to abuse me in filthy languages and assault me and has started creating pressure upon me to bring a sum of Rs. 5,00,000/- from my parents to construct house at is native place at Hoogly. His continuous mental and physical torture made me sick and when my physical condition has started deteriorating very fast and I became bedridden, then on 2 - 6 - 2021 I called my parents to take me back. It is to be mention here that though I was severely sick but my husband did not bothered to take me to any doctor and ultimately when I became fully cured at my parental house, on 23 - 6 - 2021 my husband came to my parental house and after seeking apology not to torture upon me, has taken me back to my matrimonial house. Prior to my marriage I was working in a medicine shop at Checkpost but after marriage my husband forced me to leave the job and for the peace and harmony in the family I have left the job and became fully dependent upon the mercy of my husband. It is to be mention here that after leaving from the job, whenever I demanded money for the household expenses, my husband used to insult me and mentally tortured me as beggar. My husband used to threaten me to kill and burry in land not only that he threatened me that he will put drugs in the shop of my father and inform him in criminal case and shall shut the shop of my father for ever to make us beggar.

The Gold and silver ornaments which were my stridhan property the said SK Momin @ Ali has trespassed the same and sold out and when the fact of thieving and selling of my ornaments came to my knowledge I have raised my serious objection and when I have objected on 6 - 8 - 2021 my husband mercilessly assaulted me by selling me on fursh by fist and blows not only that he gagged my mouth so that I can not raise my hue and cry but I any how managed to escape from the clutch of my husband and can be able to reach my parental house. Due to his brutal assault I became seriously ill with internal injuries and ultimately on 7 - 8 - 2021 I had been to Siliguri Sadar Hospital for my treatment.

Due to injuries I could not lodge my complaint within time and I am still under treatment.

So, requesting you to investigate the matter and take necessary legal actions against my husband for the interest of justice.
