did through Phone pay (UPI) to an account named PRABODHA LENKA, A/c No.31306004599, IFSC Code- SBIN0016440, having a Phone No. (+91)79803-61760 and still now they keep on asking me for the money I have sent a lot of money adduced in my bank statement, the transfer of amounts started from 08-08-21 to 09-08-21 and the entire sum is 1,32,000/- (one lakh thirty two thousand) and I have realized that this amount taken was a completely for the purpose of fraud and with a complete intention of deceiving me, being a government employee I have a limited source of income where I need to feed several mouths and having such theft of my hard earned money has created a lot of distress, therefore it is an earnest request for providing me justice and book the miscreants under law by recording the intimidation letter in your respected books.
