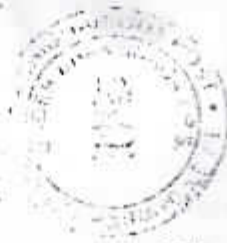

Sir,

In producing here with two arrested accused persons namely 1) Bikram Das (34) Binoy Krishna Das of C/O Ranjit Biswas, Chyanpara Bazar, PS, Bhaktinagar, Dist. Jalpaiguri 2) Smt Kamana Sarkar (21) W/O Parimal Mandal D/O Paresh Sarkar of Vill. Ververy, Monabari near SSK School PS, Mathabhanga, Dist. Coochbihar along with seized articles viz (1) 72 (Seventy Two) bottle of "CEFREX" Chlorpheniramine Maleate & Codeine Phosphate Syrup, Cough Syrup, each containing 100ml @ 137/- marketed by Shizain Drugs and Pharmaceuticals Pvt. Ltd. Batch no TBHU0232 MFD-02/2021 Exp dt. 01/2023 and 2) One blue colour Scotty having registration no. WB74AJ7207 Hero Mastro seized under proper seizure list.

I SI Pradip Kr Singha of Ashighar OP under Bhaktinagar PS, Siliguri Police Commissionerate, do hereby lodge this complainant to the effect that, today i.e. on 12.08.2021 at 15.35 hrs received a source information that two persons are rooming at Hatiadanga More with some suspicious drugs for sale in a blue colour Scotty. Accordingly, I shared the information with I/C Bhaktinagar PS and diarized the fact vide Ashighar OP GDE No 313 dated 12.08.2021 and as per his kind direction myself along with 1) ASI Sumit Baran Nath, 2) Const. 877 Munna Ahamed 3) Civic 1016 Amrit Roy, 4) LC 1312 Nilima Singha 5) Const 970 Bikash Roy all of Ashighar OP left for Hatiadanga More vide Ashighar OP GDE No. 314 to verify the veracity of the information. In the mean time, I called two persons namely (i) Dilip Ghosh (37) S/O Kalicharan Ghosh of Ghugumali, PS, Bhaktinagar, Dist. Jalpaiguri 2) Sujit Roy (30) Khiten Roy of Naresh More, Tellpara, PS, Bhaktinagar, Dist. Jalpaiguri and requested them to remain present in course of search and seizure if any. At about 15.55 hrs myself along with my accompany party arrived at Hatiadanga More. On reaching at Hatiadanga More, being identified by the source we managed to detain two persons in a Scotty having registration no. WB74AJ7207 and revealed our identity to them and shared the information. On demand, he reveals their identity as noted above. After disclosing our identity I said him whether they have any objection if search conducted in their Scotty in presence of Executive magistrate or Gazetted officer and he agreed to be searched in presence of any Gazetted Officer. I served them a notice in accordance with the provision of law in this regards. Then at 16.05 hrs I contacted with IC Bhaktinagar Police Station over RT and requested him to remain present at the spot as Gazetted officer and at about 16.25 hrs Shri Amaresh Singh, Inspector in Charge Bhaktinagar Police Station, SPC arrived at the spot. I disclosed the identity of Shri Amaresh Singh, Inspector in Charge Bhaktinagar Police Station SPC to the accused persons as Gazetted officer. Under supervision of IC Bhaktinagar PS and the above noted witnesses the Scotty was searched and recovered 72 (Seventy Two) bottle of "CEFREX" Chlorpheniramine Maleate & Codeine Phosphate Syrup, Cough Syrup, each containing 100ml @ 137/- each Marketed by Shizain Drugs and Pharmaceuticals Pvt. Ltd. Batch no TBHU0232 MFD-02/2021 Exp dt. 01/2023 in a white colour nylon bag and

covered with one yellow nylon bag from the Scotty. On being asked to produce any documents or licence in support of their possession of such restricted narcotic drugs. Then I seized the recovered drugs and Scotty as a part under proper seizure list duly sign by the witnesses and accused persons and out of which 01(One) bottle is taken as sample and Marked as Exhibit-"A". The seizure was made in between 16.30 hrs to 16.55hrs. They further confessed in presence of Gazetted officer and witnesses that they procured the restricted Narcotics drug from Kolkata clandestinely for the purpose of selling it to the drug peddlers of Siliguri with a view to earn huge money quickly. On interrogation they disclosed that they had been dealing in such business of last few years at Siliguri and surrounding area. Then I arrested the above noted accused persons after observation all formalities of arrest as well as after disclosing the cause of arrest and issued memo of arrest duly sign by the accused persons and witnesses. The copy of seizure list and memo of arrest have been supplied to the both accused persons under received. Thus the accused persons violated the terms and condition of NDPS Act for possessing such restricted Narcotic drug without any legal authority.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the accused persons namely 1) Bikram Das (34) Binoy Krishna Das of C/O Ranjit Biswas, Chyanpara Bazar, PS. Bhaktinagar, Dist. Jalpaiguri 2) Smt Kamana Sarkar (21) W/O Parimal Mandal D/O Paresh Sarkar of Vill. Ververy, Manabari near SSK School PS. Mathabhanga, Dist. Coochbihar and arrange for its investigation.
