Sub :- F. I. R. against 1. Sri Manteshwar Barman S/o Sri Mohan Barman, 2. Sri Binod Mahato S/o Sri Budhan Mahato, 3. Sri Satya Sarkar S/o late Anil Sarkar 4. Sri Ranjit Rajaj S/o not known, 5. Sri Dharani Barman S/o Not Known all are resident of Prakash Nagar, Near Shani Mandir, Sahani Busty, Ward no. 43 of S. M. C., Police Station - Bhaktinagar, District - Jalpaiguri and some other unknown miscreants who are jointly attacked me, my father Sri Shambhu Sahani and my neighbour Sri Raj Karan Singh with deadly weapon without any reason on 8/8/2021 at about 7.30 P. M. at Prakash Nagar, near Shani Mandir with an aim to kill me, my father and my neighbour and we are sustained huge injury on our vital part of the body. My father and my said neighbour are admitted in Hospital for necessary treatment. Said accused person intentionally insult me and my father publicly with intent to humiliate us because we are belongs schedule caste community and abuse us in public place in presence of local people.

Respected Sir,

I, Sri Tapeshwar Sahani son of Sri Shambhu Sahani, resident of Prakash Nagar, Near Shani Mandir, Sahani Busty, Ward no. 43 of S. M. C., Police Station - Bhaktinagar, District - Jalpaiguri beg to inform you the following facts for your kind consideration and immediate legal steps.

That on 8/8/2021 at about 7.30 P. M. said accused persons namely 1. Sri Manteshwar Barman S/o Sri Mohan Barman, 2. Sri Binod Mahato S/o Sri Budhan Mahato, 3. Sri Satya Sarkar S/o late Anil Sarkar 4. Sri Ranjit Rajaj S/o not known, 5. Sri Dharani Barman S/o Not Known all are resident of Prakash Nagar, Near Shani Mandir, Sahani Busty, Ward no. 43 of S. M. C., Police Station - Bhaktinagar, District - Jalpaiguri and their associates came at Prakash Nagar, near Shani Mandir with their motor cycle and started to throw filthy language towards the local people including me, my father and my said neighbour who were standing therein at that time. Said accused person were in drunken condition and they are all drug addicted. It is their habit to take drink and drug in public place. I, my father and my said neighbour protest against their activity and raised our voice against their unsocial attitude then suddenly said accused persons including their other unknown associates attacked on

me, my father Sri Shambhu Sahani and my said neighbour Sri Raj Karan Singh with deadly weapon like Bhojali, Ram Da, Iron Stick, wooden stick, belt etc. and due to their sudden attack I, my father and my said neighbour are sustained huge injury on our vital part of the body. It was their aim to kill us as because we are the protester against their illegal activity which they are used to commits in our locality since long in order to prove their power on our area.

Said accused person has full knowledge that I and my father are belongs schedule caste community (we have no caste certificate though my uncle's son i.e. my cousin brother has caste certificate) and due to this reasons, they are intentionally insult me and my father publicly by filthy language with intent to humiliate us because we are belongs schedule caste community and abuse us in public place in presence of local people. They openly said that they are upper class people and they have right to beat lower class people at any time and it was their version that no body has any power to stop their activities in the locality. Said accused persons and their associates beaten me, my father and my said neighbour badly but when local people were came in the spot in large number then said accused persons flew away from the spot.

My father and my said neighbour are admitted in Government Hospital and their physical condition is very bad. Said accused persons are very ferocious and dangerous in nature and they are habituated to do their illegal activities in our locality since long. Their aim was to kill me, my father and my said neighbour as because we are always raised our voice against their illegal activities and due to this reasons, they attacked on the neck of my father by Bhojali and luckily my father is still alive but fighting for survive. The photocopy of medical treatment papers of my father and my said neighbour are enclosing herewith for your kind perusal.

Under the circumstances, it is prayed before your goodself that please to look into the matter immediately after treating this complain as a F. I. R. and take appropriate legal steps against said accused persons according to the provisions of existing law of our country for the ends of justice. Hope, considering all you will do the needful in this regard at an earliest for the interest of peace and tranquility of our locality. Sir, I and my other family members are busy with the treatment of said injured persons and therefore, I have failed to lodge this complain in earliest occasion though I have informed entire facts to the Duty Officer of your Police Station in last night.
