Sub - FIR against 1. Sri Sahil Sharma S/o Sri Surender Sharma 2. Sri Surender Sharma S/o of late Nirshu Lal Sharma 3. Amit Sharma S/o prem Nath Sharma and others all are resident of Prakash Nagar, Near Milan Sporting Club, Subhas Chandra Bose Road, Ward no. 43 Of S.M.C., Police Station -Bhaktinagar, District- Jalpaiguri who have assaulted me, my family and my relatives badly today at about 7:30P.M. without any reason.

1. Sri Sudhir Sharma S/o of late Nirshu Lal Sharma, resident of Prakash Nagar, Near Milan Sporting Club, Subhas Chandra Bose Road, Ward no. 43 of S. M. C., Police Station - Bhaktinagar, District - Jalpaiguri I beg to inform you the following facts for your kind consideration and immediate legal steps.

That today at about 07:30P. M. said 1. Sri Sahil Sharma S/o Sri Surender Sharma 2. Sri Surender Sharma S/o of late Nirshu Lal Sharma 3. Amit Sharma S/o prem Nath Sharma and others all are resident of Prakash Nagar, Near Milan Sporting Club, Subhas Chandra Bose Road, Ward no. 43 of S. M. C., Police Station - Bhaktinagar, District Jalpaiguri suddenly 4 to 8 people came with the bike armed and started lashing me and my family members and relatives namely Sri Rajesh Sharma (brother), Sri Sudhir Sharma (father), Smt Surja Kala Sharma (mother) and others without any reasons. They have abused and assaulted us by lathi and bamboo, khookri and adding to the shame ripped mine and my mother's top. The people who came along with them entered into my into my house and assaulted us and snatched our jewellery. I and my said family members have sustained huge injury due to said incident and we went to the Siliguri District Hospital immediately for necessary treatment.

Under the circumstances, it is a humble request before your goodself that please to take appropriate legal steps against said persons according to the provisions of existing law for the ends of justice. Hope, considering all you will treat this complain as a F.I.R. and do the needful in this regard at an earliest. I am enclosing the O.P.D slip of Siliguri District Hospital which issued by the Hospital authority after our preliminary treatment. I and my said family members are badly injured due to said incident and still we are not well, therefore, I have failed to lodge my complain earlier before your goodself.
