Subject: F.I.R for unauthorized usage of Electric energy

Dear Sir,

I, Suman Sengupta, Divisional Engineer (E), Power House CCC, WBSEDCL, Siliguri son of Sri. Ashoke Sengupta, empowered by The Electricity Act 2003 amended on 2007 of India do here by lodge this complain against Sri Saroj Rastogi (Cell-9832022226), New Prakash Nagar, P.S. - Bhaktinagar, Dist. Jalpaiguri, During a routine inspection today on 12.08.2021 at about 14:45 Hrs, myself along with 1) Sri. Aourba Mitra, Jr. Manager (HR&A), Power House CCC, WBSEDCL, and others supporting staff had been to the spot at New Prakash Nagar, P.S. Bhaktinagar, Dist- Jalpaiguri had observed an unauthorized use of electricity. On physical inspection it was found that, an extra line with 1.5 mm copper service cable is going out from the direct LT Network, for charging of an Inverter and usage of exhaust fan in side vehicle no. WB-74 - W- 8354 via hooking from direct LT Network.(total of 720 watts was found).Accordingly an inspection report was prepared and seized 1 nos of exhaust fan (Havells make, 40watts), 1 nos of Inverter(Microtek make, 800VA) with 1 nos of Battery (Exide make, Inva Plus Tubular, 12 Volt) and service cable (1.5mmsq, Copper, multi stranded, of 30 mtrs approx) after preparing a seizure list duly signed by the witnesses and Smt Sujata Rastogi, wife of Sri Saroj Rastogi. Then we handed over the copies of all (inspection report & seizure list) documents to Mrs. Sujata Rastogi, w/o Saroj Rastogi. We exited the site at 15.15 hrs.

Thus you are requested to kindly initiate an investigation against Sri Saroj Rastogi under Section 135(1) (a) of the electricity act 2003 amended act 2007 of India.
