Sir,

In producing herewith arrested accused person namely Khusbu Sahani (21) W/O Debu Sahani of Tikiapara, Matangini colony-II , Ward No. 28, PS- Siliguri, Dist- Darjeeling along with child in her Lap along with seized articles vize- i) 11 (eleven) sealed bottles of Himalayan Gold 60 up country spirit containing 600 ml. each labeled as Himalayan Endeavour PVT. Ltd. Siliguri, West Bengal @ Rs 100 each (Amounting of 11 x Rs 100/- =RS.1100/-) and ii) 06 sealed bottles of McDowel'd No1 Celebration Matured xxx RUM containing 180 ml each (amounting of Rs. 153x06 = Rs. 918/-) as per seizure list.

I, ASI Siben Sarkar of Siliguri PS, SPC do here by lodged a written complaint against above noted arrested accused person Khusbu Sahani (21) W/O Debu Sahani of Tikiapara, Matangini colony-II , Ward No. 28, PS- Siliguri, Dist- Darjeeling along with child in her Lap to the effect that on 14.08.21 at 08.25 hrs acting on secret information, I received a source information that the above noted person was busy to sale Id liquor illegally at her house situated at Tikiapara, Matangini colony-II under Siliguri PS in order to clandestinely dispose the same. Accordingly the fact is diarized in GD vide Siliguri PS GDE no. 889 dated 14.08.21 and informed the fact to I/C Siliguri,PS. As per direction of I/C Siliguri PS, I along with LC/1295 Swastika Rai, CV/283 Prosenjit Dey & CV/622 Ramanath Barman left for Tikiapara, Matangini colony-II under Siliguri PS to verify the veracity of the information vide Siliguri PS GDE No. 890 dated 14.08.21. On reaching at 08.45 hrs there and as identified by source cordoned the above noted area where she was selling illegal alcohol. On seeing the police party the above noted person tried to escape from the spot but we managed to apprehend the above noted person with the help of lady constable and on interrogation, the above noted person disclosed her identity as noted above. On searching i) 11 (eleven) sealed bottles of Himalayan

Gold 60 up country spirit containing 600 ml. each labeled as Himalayan Endeavour PVT. Ltd. Siliguri, West Bengal @ Rs 100 each (Amounting of 11 x Rs 100/- = Rs. 1100/-) and ii) 06 sealed bottles of McDowell's No1 Celebration Matured xxx RUM containing 180 ml each (amounting of Rs. 153x06 = Rs. 918/-) which was kept concealed in her house. On being interrogation she could not produce any valid documents in respect of the said liquor. She also stated that she is doing this liquor business since long for wrongful gain. Accordingly I seized the same in presence of witness duly signed by them. The seizure and label was made in between 08.55 hrs to 09.55 hrs. On being asked she stated that she used to sale the same to locality without any valid documents as she has violated the norms of Bengal Excise Act for selling the said seized articles without any valid license. As such I arrested her U/S-41 Cr.P.C after observing all sorts' of rules.

Therefore I pray before your honor that a specific case may kindly be started against the arrested accused person Khusbu Sahani (21) W/O Debu Sahani of Tikiapara, Matangini colony-II , Ward No. 28, PS- Siliguri, Dist- Darjeeling along with her child in her lap along with seized articles under proper section of law and arrange for its investigate.
