Sir,

I, A.S.I Jakirul Islam of Bagdogra PS, Siliguri Police Commissionerate, do hereby lodge this written complaint, on producing one arrested accused person namely Hari chettri (57) s/o Lt. Kanu Chettri of Taipoo Hatkhola PS Bagdogra Dist. Darjeeling under arrest along with following seized articles;

1. Ten (10) Bottles of Himalayan Gold 60 Up Country Spirit each bottle containing 600 ml
2. Seven (7) Bottles of Captain 60 Up Country Spirit each bottle containing 300 ml
3. Six (6) bottles of Mc Dowell's celebration Matured XXX RUM each bottle containing 180 ml
4. Four (4) bottles of Royal Bouncer whiskey each bottle containing 180 ml

I am submitting a written complaint against the above noted accused person to the effect that on 14.08.21 at 14-50 hrs I received a information that at Taipoo Hatkhola under PS Bagdogra one person was selling liquor to its customers illegally without any valid license from in front of his house at Taipoo Hatkhola. Accordingly I informed the matter to O.C. Bagdogra PS and as per instruction myself along with ASI Dhirendra Nath Mondal and C/410 Montosh Jha CV- 386 Kishor Halder, VP- 01 Ansarul Kujur, VP-02 Pradip Roy had been to the spot to verify the veracity of information vide Bagdogra PS GDE No 1064 Dt:- 14.08.21. On arrival at the spot at 15:25 hrs it was found that one person mention above was selling liquor from infront of his house at Taipoo hatkhola to the customer illegally to earn huge money for his livelihood. On seen the police party the common customers as well as seller tried to fled away, but the seller was apprehended by Police, On being asked he disclosed his name and address mentioned above. There after I called two disinterested witnesses from there namely (1) Bishnu Singha (36) s/o Lt. Nipen singha of Hela Kadam Jote Ps Bagdogra Dist. Darjeeling (2) Bijay Chettri (24) s/o Rajen chettri of Taipoo Hatkhola Ps Bagdogra Dist. Darjeeling, in the very presence of the witnesses I searched and seized the above mentioned liquors from the possession of the apprehended person and preparing proper seizure List duly signed by him and also witnesses. On being asked the said person failed to produce any document or license for stocking and selling liquor from that place. It's a violation under Bengal Excise Act. This seizure & arrest was made in between 15-35 hrs and 16-05 hrs (total 9.9 Lts).

Therefore, I request you to start a specific case under proper section of law against the arrested person namely Hari chettri (57) s/o Lt. Kanu Chettri of Taipoo Hatkhola PS Bagdogra Dist. Darjeeling and arrange for its investigation.
