ml.



I ASI Debasish Das of Pradhannagar PS, SPC would like to lodge this written  
complainant against the above noted accused person to the effect that on 11.02.21  
at 13:10 hrs myself along with force, LC 332 Tania Roy CV/128 Ajay Kr  
Sahani, CV/223 Swapan Chettri left from PS for Special mobile van duty vide PDN PS  
GDE NO 734 at about 13.15 hrs .During mobile duty I received a information that one  
person namely Pampa Dutta (45) w/o Lt Lakhnan Dutta of Baghajatin colony 45/3 Dist  
Darjeeling storage huge quantity of illegal liquor in his petty shop situated at  
Baghajatin colony Pradhannagar PS and selling the same in his shop. Accordingly I  
share the information to you and as per your kind instruction myself along with force  
rush to the spot and hold raid in the shop noted above and detained the above noted  
person and on being search his shop recovered above noted articles , On demand she  
failed to produce any valid document in respect of recovered articles .On interrogation  
she admitted that she is selling the same illegally without obtaining valid document  
for her illegal gain. Accordingly I seized & label the above noted articles in between  
13.20 hrs to 13.45 hrs and then I arrested her.

Therefore, I request you to start a specific case under proper section of law  
against the arrested person Pampa Dutta (45) w/o Lt Lakhnan Dutta of Baghajatin  
colony 45/3 Dist Darjeeling and arrange for its investigation.
