With due respect and humble submission, in producing herewith one accused person namely **Lal Bahadur Mandal (M-30) S/O Devendra Mandal of Samastipur Village, Hayaghat P.S, Dist. Darbhanga (Bihar)** Under arrest along with following articles under proper seizure as Follows:-

- i) **08 (eight) Bottles of Himalayan Gold 60 UP Country Spirit each bottle containing 600 ml.**
- ii) **10 (ten) Bottles of Himalayan Gold 60 UP Country Spirit each bottle containing 300 ml.**
- iii) **12 (twelve) Bottles of Officer's Choice Deluxe Whisky each bottle containing 180 ml.**

I P.S.I Kalyan Saha of Pradhan Nagar P.S, S.P.C would like to lodge a written complainant against the above noted accused person to the effect that on 13.08.2021 at 20:25 hrs myself along with officer and force, A.S.I Debasis Das, C.V/128 Ajay Kr Sahani, CV/223 Swapan Chettri , CV 992 Jagadish Biswas left from P.S for Special mobile van duty vide PDN PS GDE NO 854. During special mobile van duty I received a information that one person namely Lal Bahadur Mandal (M-30) S/O Devendra Mandal of Samastipur Village, Hayaghat P.S, Dist. Darbhanga (Bihar) storage huge quantity of illegal liquor in his shop situated at Gol Ghar, Regulated Market, under P.S.-Pradhan Nagar, Dist.- Darjeeling and selling the same in his shop. Accordingly I share the information to you and as per your kind instruction myself along with force rush to the spot and held raid in his shop noted above and detained the above noted accused person and on being search his shop recovered above noted articles, On demand he failed to produce any valid document in respect of recovered articles .On interrogation he admitted that he is selling the same illegally without obtaining valid document for his illegal gain in this lockdown. Accordingly I seized & labelled the above noted articles. The seizure was made in between 21:45 hrs to 22:10 hrs and then I arrested the above noted accused intimating the ground of arrest.

Therefore, I request you to start a specific case under proper section of law against the arrested person namely Lal Bahadur Mandal (M-30) S/O Devendra Mandal of Samastipur Village, Hayaghat P.S, Dist. Darbhanga (Bihar) and arrange for its investigation.
