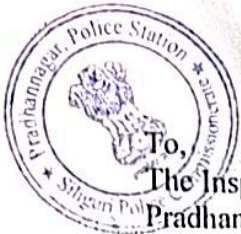

Sir,

I ASI Debasish Das of Pradhannagar PS, Siliguri Metropolitan Police, do hereby lodge this written complaint, on producing one Sambhu Sharma (28) s/o Chabilal Sharma of Promod Nagar, PS Pradhannagar, Darjeeling under arrest along with following seized articles viz; a) Twelve (12) sealed bottles of 60 up country Spirit each bottles contains 600 ml. b) Six (06) sealed bottles of Kingfisher strong beer each beer containing 650 ml, c) Seven (07) packet of tetra pack of officer choice deluxe whiskey each containing 180 ml under seizure list (which is enclosed herewith) to the effect that on 14/8/21 at 16:45 hrs received a source information that one person has been selling a liquor at the side of Darjeeling more main road, PS Pradhannagar without any valid license. Diarized the matters vide PDN PS GDE No 917 Dt- 14/8/21. Accordingly I informed the matter to I/C Pradhannagar PS, SMP. As per kind direction myself along with ASI Ratan pradhan, CV 223 Sapan Cheetri left for the spot to verify the veracity of the source information. On reaching at the spot at 17:00 hrs it was found that one person was sitting at the side of the Darjeeling more main road and selling liquor secretly. On being seen the police party the above noted person tried to flee away but apprehended by the police party. On being asked he confessed that he is selling the liquor in roaming at the various place secretly for his wrongful gain. Thereafter I called two disinterested witnesses from there and in the very presence of those witnesses I seized the above noted liquor preparing proper seizure List duly signed by them from the possession of Sambhu Sharma (28) s/o Chabilal Sharma of Promod Nagar, PS Pradhannagar, Darjeeling. On being asked the said person failed to produce any document or license for selling the said liquor in his shop. It's a violation under Bengal Excise Act. This seizure was made in between 17:05 hrs and 17:35 hrs (total 12.36 Lts). I then arrested the accused person Sambhu Sharma (28) s/o Chabilal Sharma of Promod Nagar, PS Pradhannagar, Darjeeling after preparing memo of arrest and intimating the ground of arrest.

Therefore, I request you to start a specific case under proper section of law against the arrested person namely Sambhu Sharma (28) s/o Chabilal Sharma of Promod Nagar, PS Pradhannagar, Darjeeling and arrange for its investigation.
