In producing herewith two (02) arrested accused person namely 1. Shakti Ghosh 34 yrs s/o Khokan Ghosh of Naxalbari Roy Para Naxalbari Ps Naxalbari, Dist. Darjeelijn 2. Allmuktar Sk 32 yrs s/o Late Didar Ali Vill: Baliadanga Kaliachok PS, Kaliachok Dist, Malda West Bengal along with following seized articles viz,

- i. One zipper transparent thin plastic packet in contents 200 grms (Two hundred) believe to be brown sugar, recovered from the possession of Shakti Ghosh Market as Exhibit -A.
- ii. 10 (Ten) grams of believe to be brown sugar which drawn from exhibit-A as sample for examination packed, sealed, labeled and marked as exhibit-A-1.
- iii. One zipper transparent thin plastic packet in contents 140 grms (one hundred forty) believe to be brown sugar, recovered from the possession of Allmuktar Sk Market as Exhibit -"B".
- iv. 10 (Ten) grams of believe to be brown sugar which drawn from exhibit- "B" as sample for examination packed, sealed, labeled and marked as exhibit-"B-1".

I, SI Bapi Ch Dey of Bagdogra Ps, Siliguri Police Commissionerate do here by lodged this complaint against 1. Shakti Ghosh 34 yrs s/o Khokan Ghosh of Naxalbari Roy Para Naxalbari Ps Naxalbari, Dist. Darjeelijn 2. Allmuktar Sk 32 yrs s/o Late Didar Ali Vill: Baliadanga Kaliachok PS, Kaliachok Dist, Malda West Bengal to the effect that on 16.08.21 at 15.00 hrs received a secret source information that two persons having possession huge quantity of brown sugar are standing at Kestopur More for clandestinely disposal of the same illegally at and around Siliguri Matigara and Naxalbari area. The matter was diarized vide Bagdogra Ps GDE No-1159 dt- 16.08.21. Accordingly, I informed the matter to O.C, Bagdogra PS as per his instruction myself along with ASI Jakirul Islam, ASI Madan Rishi, C/410 Montosh Singh, VP- 02 Pradip Roy, CV/389 Janak Singha and CV, 375 Jogesh Singha left for the spot at 15.05 hrs to verify the veracity of the information vide corresponding Bagdogra Ps G.D.E. No. 1160 dtd 16.08.2021 and Bagdogra Ps M.C.C No- 1495/21 Dt. 16.08.21. At the time of departure from Police Station, I bring spring weighing clock, small balance with stone, envelope, white paper, sealing wax, gum, seal etc. On way to spot at Kestopur More meanwhile I called two independent witnesses namely 1. Md Posir 40yrs s/o Late Hafiz Uddin of Chowpukuria Halal Ps Bagdogra Dist. Darjeeling 2. Sani Teli 36yrs s/o Late Aklu Teli of Kiran Chandra, Tea Estate Nadi Line Ps Bagdogra Dist. Darjeeling informed them about the information in hand and requested them to accompany us to witness the search and seizure if necessary. At about 15.20 hrs on arrival there by govt. vehicle parked the vehicle in a considerable distance as identified by the source we surrounded the place and found two persons were standing at Kestopur More near one lottery shop on seeing police party, they try to flee from there on hot chase, we apprehended the two persons. On being asked they disclosed their identity as noted above. After disclosing our identity, I asked them whether they wanted to be searched in presence of Executive Magistrate or any Gazetted Officer and they agreed to search by any one. I served them option notice accordance with provisions of law in this regard in writing and they also gave their approval of being searched by any one in writing in the notice serve to them. Accordingly, I informed the matter to O.C. Bagdogra Ps and he informed me over mobile phone to send one requisition to Sri Pasang Topgay Bhutia, ACP, Traffic (West), SPC Special Executive Magistrate of SPC for the day. Accordingly I informed to Sri Pasang Topgay Bhutia, ACP, Traffic (West), SPC, Special Executive Magistrate of SPC for the day and request to came to the spot. At about 16.35 hrs Sri Pasang Topgay Bhutia, ACP, Traffic (West), SPC, Special Executive Magistrate of SPC for the day and O.C. Bagdogra Ps arrived at the spot. I

disclosed the identity of Sri Pasang Topgay Bhutia ,ACP, Traffic (West), SPC, Special Executive Magistrate of SPC for the day to the accused persons and also witnesses. I also per provision of law. But they refused to search our Police Party as Pasang Topgay Bhutia ,ACP, Traffic (West), SPC, Special Executive Magistrate of SPC for the day and in presence of independent witnesses, I conducted searched and recovered One concealed on the right pocket (half pant) of Shakti Ghosh on weighing by the weighing instrument and found total 200 gram believe to be brown sugar and Marked as Exhibit -"A" thin plastic packet and marked as "A-1" on search of Allmuktar Sk recovered One zipper on the left pocket (Full pant) on weighing by the weighing instrument and found total 140 gram and Marked as Exhibit - "B" and 10 Grams said to brown sugar taken as sample from the Exhibit -"B" in one separate thin plastic packet and marked as "B-1" believe to be brown sugar . On demand in presence of the Special Executive Magistrate of SPC for the day Sri Pasang Topgay Bhutia, ACP, Traffic (West), SPC, they failed to produce any valid document in support of possessing of the same.


I accordingly labeled and sealed all the article in presence of Sri Pasang Topgay Bhutia , ACP, Traffic (West), SPC, Special Executive Magistrate of SPC for the day and independent witnesses and accused persons. Then I seized the above noted articles under proper seizure list and label duly signed by the above noted witnesses and the Special Executive Magistrate of SPC for the day Sri Pasang Topgay Bhutia ,ACP, Traffic (West), SPC and acknowledged by the accused persons. The seizure was made between 16.45 hrs to 17.55 hrs. On further interrogation both the apprehend persons Shakti Ghosh & Allmuktar Sk confessed in presence of Special Executive Magistrate of SPC for the day Sri Pasang Topgay Bhutia ,ACP, Traffic (West), SPC and other witnesses that they procured the said brown sugar clandestinely from Kaliachok Malda and Shakti Ghosh bring to Panitanki to sell the same from his grocery shop located at Panitanki Nepal Border and Allmuktar Sk sale the same at Khaprile more under Matigara PS, to his one designated customers as they are addicted to brown sugar and also the purpose of selling in order to earn huge money quickly during the time of pandemic situation. Then, I arrested the above noted two accused persons u/s- 41 Cr.P.C after observing all formalities of arrest as well as after disclosing the cause of arrest and issued Memo of Arrest .The copy of seizure list and Memo of Arrest has been supplied to above noted accused persons under proper receipt as the accused persons violated the terms and condition of NDPS Act .

Under the above circumstances, I pray to you that a specific case under proper section of Law may kindly be started against the accused persons namely 1. Shakti Ghosh 34 yrs s/o Khokan Ghosh of Naxalbari Roy Para Naxalbari Ps Naxalbari, Dist. Darjeelimg 2. Allmuktar Sk 32 yrs s/o Late Didar Ali Vill: Baliadanga Kaliachok PS, Kaliachok Dist, Malda West Bengal and arrange for its investigation.
