Sir,

With due respect, I, ASI Sadananda Debnath of Bagdogra PS, Siliguri Police Commissionerate, do hereby lodge this written complaint against (1) Manish Gupta (2) Pankaj Gupta and 30/35 others to the effect that on 17.08.21 from 14.00 hrs I took up my G.D. Duty at Police Station. While taking up my duty from ASI Ashish Karmakar (1st GD Duty Officer) informed me that SI Dipanjan Bhadra, SI Dipankar Chakraborty, ASI Madan Kishi and LSI Rajani Chettri along with force brought in 49 accused persons all supporters of BJP and Narayani Bena, supporters of Greater Cooch Behar, those who were found at Airport More under Bagdogra moving freely without wearing Facial Mask on the spot completely violating order of State Government vide No. 753/IV-188/2M-22/2020 Dated 29/07/2021 and recent order No. 753/V-188/2M-22/2020 Dated 13.08.2021 and earlier orders promulgated to contain the spread of Covid-19 virus. Therefore, they were arrested and brought to Police Station and were in Police Custody. Over this incident four specific case vide Bagdogra PS Case No. 402/21, 403/21, 404/21 & 405/21 dtd. 17.08.21 u/s 188/269 IPC r/w Sec. 51(b) Disaster Management Act has been started against them. All the arrested persons were in Police Custody at Bagdogra Police Station.

Thereafter, at about 14-30 hrs huge number of BJP supporters under the leadership of (1) Manish Gupta (2) Pankaj Gupta and 30/35 others in aggressive mood came to Police station with intention to bring out and release the arrested persons and forcibly tried to enter inside the Police Station. They were using abusive and filthy languages against the police personnel and demanded immediate release of arrested persons. I along with on duty Police personnel tried to convince them that they had been arrested in c/w specific criminal case and in order to release them proper legal procedure had to be followed, but they paid no heed. The mob started sloganeering against Police demanding immediate release of arrested persons and started making an attempt to enter inside Police Station. Then, on duty Police personnel obstructed and restrained them from entering inside, at that time, they indulged in scuffling with the on duty Police personnel and also started forcibly pushing the Main gate made up of glass, as a result the Glass of the main gate broke and on duty LC-1299 Rosy Lepcha sustained bleeding injury on her hand. On seeing that the persons who had become aggressive and scuffled with Police personnel fled away from the spot. Later, the lady constable was shifted to Bagdogra Primary Health Centre for medical aid.

The above noted persons voluntarily obstructed Police personnel from discharge of public duty and used criminal force to cause hurt of lady constable while she was discharging her duty and they also used criminal force to deter Police personnel from discharging their duties.

I therefore, pray before you that a specific case may kindly be started against the above noted accused persons and arrange for investigation.
