Sir,

With due respect I, Smt. Gita Barman, W/o Sri. Kalidas Barman, residing at Stalin Nagar, Uttar Bagdogra, P.O. Bagdogra, P.S. Bagdogra, Dist. Darjeeling would like to inform you that I was married to Sri Kalidas Barman on 20-02-2003. Since few months of marriage he started neglecting me and after the birth of our two daughters he totally started neglecting and torturing me mentally and physically and my daughters as he did not like daughters, he always wanted a son.

Thereafter I filed a domestic violence case against my husband Kalidas Barman, S/o Late Jogeshwar Barman in the year 2016 before the Ld. JM 1st court at Siliguri being Misc Case No. 41/2016, which is still pending, and two execution case is still pending and an arrest warrant has being also issued against him from the Ld. JM 1st Court and still he did not even pay monthly maintenance to me and my daughters and we were leading a miserable life and starving for food. He never pays any maintenance to us during his service and now he had voluntarily retired from his service and had withdrawn all his pension benefits and living his life peacefully at his present address C/o Late Jogeshwar Barman, Brahmanir Chauki, Dinhata, P.S. Dinhata, Dist. Cooch Behar, West Bengal and he is constructing a new house at

So many times I tried to contact him but he did not receive my call and even never calls back. Now I came to know from sources that he had an extra marital affairs with a widow lady and recently he had married that widow lady and he has a son. He is a fraud man with no heart. I am still his legally married and without any legal divorce he had married another lady and cheated me and he is never paying any maintenance to us in this pandemic situation and we are all maintained by my father.

I am in great pain and need of my husband but he has ditched me and abandoned me and my daughters.

I would request you to kindly register the complain and take necessary action to punish him for all his deeds.
