Rabi Tamang of Ambari Falakata OP under NJP PS/SPC beg to report that on 13.08.21 in course of Special mobile van duty vide Ambari OP GDE No- 436 dated on 13.08.21 myself along with force namely C/505 Tapash Dutta and (2) NVF/108 Swadesh Roy and both of Ambari-Falakata OP, Under NJP PS/SPC had been to Nawapara More, under Ambari Falakata OP. PS. NJP to perform Special mobile Van duty at 16:55hrs I found the above noted persons were roaming without face mask at that area and violated the Government Order (Lock Down) in c/w outbreak of COVID-19. Accordingly, the above noted persons were detained. On being interrogation they disclosed their identity as mentioned above and further they failed to give any satisfactory answer regarding their movement in that area rather they refuse to comply with direction of the Government Order regarding lockdown in c/w outbreak of Covid-19. Hence I arrested them u/s 41 Cr.P.C after issuing copy of Memo of arrest and inform their ground of arrest.

Therefore I pray before your good office that a specific case under proper section of Law may kindly be started against the above noted accused persons namely (1) Md. Sarwar Mannan (29yrs), S/o.
