I, SI. Phup Rinchey Bhutia of Ambari Falakata OP under NJP PS beg to report that on 17.08.2021 in course of Special Naka Duty Vide Ambari OP GDE No- 546 Dated 17.08.2021 myself along with force namely (1) ASI. Sailendra Singh (2) NVF/130 Dhana Deb Roy (3) HG/749 N. Sarkar and L/C-741 Mallika Roy had been to Nawapara More, under Ambari Falakata OP and performing Naka Checking Duty as per order of O/C. at about 09:45 hrs and found that the above noted persons were boarded in their vehicle bearing registration No. WB71B5620 Scorpio without social distancing and without wearing face mask at Nawapara More and violated the Government Order (Lock Down) in c/w outbreak of COVID-19. Accordingly, the above noted persons were detained. On being interrogation they disclosed their identity as mentioned above and further they failed to give any satisfactory answer regarding their movement in that area rather they refuse to comply with direction of the Government Order regarding lockdown in c/w outbreak of COVID-19. Hence, I Seized their vehicle i.e. one Scorpio bearing registration No. WB71B5620 along with all connected papers of above noted vehicle and arrested them U/S 41 Cr.P.C after issuing copy of Memo of arrest and inform their ground of arrest.

Therefore, I pray before your good office that a specific case may kindly be started under proper section of Law against the above noted accused persons and arrange for its investigation.
