Phup Rinchey Bhutia of Ambari Falakata OP under NJP PS beg to report that on 17.08.2021 in course of Special Naka Duty Vide Ambari OP GDE No- 546 Dated 17.08.2021 myself along with force namely (1) ASI. Sailendra Singh (2) NVF/130 Dhana Deb Roy (3) HG/749 N.
