In producing herewith 02 (Two) arrested accused persons U/s 41 Cr.P.C who disclosed their identity as (1) Arjun Prasad Gupta (36 Yrs) S/O Samu Prasad Gupta of Pradhannagar, Ward No. 01, Dist- Darjeeling (2) Sekh Ahamed (64 Yrs) S/O Sekh Ajj of Champasari, PS- Pradhannagar, Dist- Darjeeling.

I, SI Azizul Haque of New Jalpaiguri Police Station, SPC do here by lodged this written complaint against the above noted persons to the effect that today (17/08/21) in between 12:15 and 13:55 Hrs in course of performing Morning mobile van duty he along with force went to Noukaghat More and found (1) Arjun Prasad Gupta (36 Yrs) S/O Samu Prasad Gupta of Pradhannagar, Ward No. 01, Dist- Darjeeling (2) Sekh Ahamed (64 Yrs) S/O Sekh Ajj of Champasari, PS- Pradhannagar, Dist- Darjeeling were boarded in their vehicle bearing registration No. WB 73E 7829 Bolero Pickup without social distancing and without wearing face mask. On interrogation they also stated that they were well aware of Govt. order regarding pandemic situations and wearing of facemasks was mandatory in public places in the current pandemic situation.

They all are violated the order of Govt. of West Bengal vide Memo No. 486-CS/2021 dt. 24.04.2021. Hence, I arrested them in c/w the case under proper memo of arrest in between 12:15 and 13:55 Hrs and seized the vehicle bearing registration No. WB 73E 7829 Bolero Pickup after prepare proper seizure list duly signed by them in presence of witnesses and inform the ground of arrest.

Hence, I, request you for starting a specific case U/S 188/269/270 IPC r/w sec 51 (b) of disaster Management Act.2005 against the above noted accused persons and arrange proper investigation of the case.
