Dear Sir,

I, Malay Kumar Goswami, DE (S&LP), Darjeeling Regional Office do hereby lodge this written complaint against Reba Saha, W/o- Lt. Ananda Saha of Chayanpara, Ghogomali, near : Junior Sangha Club, P.S. - Bhakti Nagar, Dist.: Jalpaiguri, (M) 8250124993 / 9832013010 for unauthorised usage of Domestic connection having Con. ID : 412133962 Meter no.: L3571591 for commercial purpose. She use this domestic line for charging of approx. 10 nos. TOTO Rickshaw illegally and unauthorisedly and thereby liable under Section 135(i)(e) of Electricity Act.

Today (12.08.2021) at 13.15 hrs. I, along with Sri Kausick Kumar Das, AE & SM, SP CCC and other supporting staff of Mobile Van had been to the above address for inspection. During inspection the said person is consuming the electricity energy approx. present demand 2KW having contractual load of 1KW by using Domestic Connection for Commercial purpose unauthorisedly and illegally. The present reading of the said meter is 28268 units.

Accordingly I issued a notice and served a copy to the consumer. As the unauthorized use of electricity detected, the service connection has been disconnected with removal of said energy meter, also prepare the inspection report followed by the seizure of energy Meter [L3571591 Landis Gear Make] and supplied the copies of it to the representative of the premises owner.

- (i) One Single core PVC 2 core service wire, approx. length 3 ft. as sample.
- (ii) 3 ft. Flexible wire as sample which was been used for TOTO Charging.
- (iii) One energy meter bearing no. : L3571591 Landis Gear Make, IPH (5-30)A.

So, It is requested that a case Under Section 135(i)(e) of Electricity Act. may kindly be initiated against Reba Saha and arranged for its investigation.
