In producing herewith one accused person namely Gopal Chettri (51) S/O Lt. Tek Bahadur Chettri of Chota Sapri, P.O- Salugara, PS- Bhaktinagar Dist- Jalpaiguri along with the following seized articles as per proper seizure list:

1. Fifteen (15) Bottles of Himalayan Gold 60 UP country spirit (each bottle containing 600 ML).

I, SI Srimanta Chatterjee of Bhaktinagar PS, SPC lodged a written complainant against the above noted person to the effect that today i.e. on 13.08.2021 hrs at 19.20 hrs received a source information that at the Tea Shop of Gopal Chettri (51) S/O Lt. Tek Bahadur Chettri of Chota Sapri, P.O- Salugara, PS- Bhaktinagar Dist- Jalpaiguri has gathered huge amount of liquor illegally for selling the same in the customer for his wrongful gain. This refers to Bhaktinagar PS GDE No- 762 dated 13.08.2021. I informed to I/C Bhaktinagar PS about the information. As per his kind instruction I along with, ASI Biplob Kumar Das, CVF/619 Dharmendra Roy, CVF/614 Sumit Kr.Roy as proceed to at Sevoke Road opposite Canara Bank, PS- Bhaktinagar, Jalpaiguri to work out the information. At 19.30 hrs we reached at the spot, sometimes after being identified by the source our police party held raid at the Tea Shop of Gopal Chettri (51) S/O Lt. Tek Bahadur Chettri of Chota Sapri, P.O- Salugara, PS- Bhaktinagar Dist- Jalpaiguri and recovered the above noted articles from the possession of above noted accused person namely Gopal Chettri (51) S/O Lt. Tek Bahadur Chettri of Chota Sapri, P.O- Salugara, PS- Bhaktinagar Dist- Jalpaiguri. On demand he could not produce any valid license/documents in support of said liquor. He become nervous and admitted his guilt before us and stated that he sell the same in the customer since long for his wrongful gain. In presence of witnesses namely 1) Satish Singh S/o Brij Kishore Singh of Ghandhi Nagar near house of Dilip Singh, P.S Bhaktinagar, Dist. Jalpaiguri 2) CV-614 Sumit Kr. Roy of Bhaktinagar P.S. I seized the above noted articles from the possession of above noted accused person after preparing proper seizure list and took signature of the accused person and witnesses. The seizure was made between 19.40 hrs to 20.50 hrs. I arrested the said person u/s 41 Cr.P.C. and issued Memo of arrest appraising the ground of arrest in presence of witnesses.


